The biennial specialized International Defence Equipment Exhibition “HEMUS” was established in 1995 with a decision of the Council of Ministers of the Republic of Bulgaria to be held at the International Fair Plovdiv venue.

The Exhibition is held under the patronage of the Ministry of Defence and the Ministry of Economy of the Republic of Bulgaria.

“HEMUS-95” Foundation, the Principal of which is the Ministry of Defence, has undertaken the financing of the Exhibition and the immediate arrangements.

Over the course of its over 29 year existence, the Exhibition has pursued and achieved its main goal - to give an impetus to the development of the Defence Industry, providing the manufacturers and business people a focal point to showcase armaments and combat equipment along with the whole spectrum of defence assets. The Forum creates opportunities for the establishment of joint-venture enterprises, maintenance and repair activities and joint innovative Research & Development projects in the area of defence and security.

Since 2011, the concept of the Exhibition has been expanded and enriched to involve three more perspectives: Defence, Antiterrorism and Security. Special role has been assigned to innovations and research and development promoted by scientific conferences, demonstrations and test firings, presentations of academia and higher educational institutions, etc.

The Fifteenth edition of the International Defence Equipment and Services Exhibition “Hemus 2022” took place from 1-st to 4-th June, 2022 at the Plovdiv International Fair. The Event was held in complex geopolitical and economic conditions. Significant efforts were made by the organizers to ensure not only attractive but also safe venue and conditions for exhibitors and visitors.

Despite the complex situation, “Hemus 2022” has achieved significant growth in all trade parameters compared to the previous edition in 2020. On an exhibition area of a total of 4284 sq.m., of which 2039 sq.m. covered and 2245 sq.m. opened, 100 companies and organizations were presented, of which 59 Bulgarian and 41 foreign from 21 countries. Among our esteemed exhibitors, to whom we offered hosting, was once again a Contingent from the US Army, which participated in the Static Display together with Bulgarian military formations. This contingent, as well as the military personnel from the United Kingdom who visited the exhibition, were part of the NATO Multinational Battalion Battle group formed on the territory of the Republic of Bulgaria.

The Bulgarian Academia continued to show significant interest, as a total of 11 Scientific bodies and Universities, of which 5 military and 6 civilian, took part as exhibitors in “Hemus 2022”.

In general, regardless of the complex economic and geopolitical situation in the world, the achieved commercial parameters of “Hemus 2022” exceeded by 10% to 50% what was achieved in the previous edition.

This edition of the exhibition caused widespread interest and visits from a number of representatives of the Bulgarian state institutions, from official delegations and guests of the Minister of Defense, from the diplomatic corps, from representatives of Bulgarian and foreign business and last but not least, from numerous Bulgarian and foreign citizens. On the Bulgarian side, the exhibition was viewed by the President of the Republic of Bulgaria, by representatives of the Parliament, by the Minister of Defense, by Deputy Ministers of Defense, of Economy and Industry and of Innovation and Growth, by the Chief of Defense, by the Commanders of Services, Generals and Admirals.

The exhibition was also visited by 18 foreign delegations, guests of the Minister of Defense. Along with the official delegations, “Hemus 2022” had visitors from 50 countries from Europe, North and South America, Australia, Africa and Asia. A number of countries were represented by their Defense Attachés in Sofia and other visitors.

The total number of visitors to the exhibition and its accompanying events exceeded 3,000 people, which means that the positive trend of increasing attendance is maintained.

The exhibition and accompanying events were covered by representatives of over 36 Bulgarian and foreign media.

The exposition in practice continues to cover the full cycle of the development of a defence product or service – education and training, innovation, R&D, production, commercialization, acquisition, life-cycle support and utilization.

The expanded international participation and the strong international, European and Euro-Atlantic interest shown in the exhibition made it a high-level international forum for the realization of interests, both in the business-to-business domain, as well as in the state-to-state and business-to-state domains.

The exhibition was opened by the President of the Republic of Bulgaria and Supreme Commander in Chief of the Armed Forces, Rumen Radev. The Minister of Defense, Dragomir Zakov, addressed the exhibitors and visitors with a greeting.

Immediately after the opening, according to established tradition, a dynamic display was held, in which a helicopter and airplanes from the Bulgarian Air Force took part.

“Hemus 2022 “ has established itself as an extremely successful platform for business meetings of all kinds - g2g, g2b, b2b. Thanks to a previously reworked mechanism, more than 60 business meetings of various types were requested, organized and held, both at the request of the delegations and other visitors, and at the request of the exhibitors themselves.

Regarding the g2g format , all official delegations held business meetings with the leadership of the Bulgarian Ministry of Defense, and many of them - bilaterally.

Traditionally the Exhibition was accompanied by conduction of Live Demonstrations and Static display of armament and equipment of the Armed Forces of the Republic of Bulgaria and the Ministry of Interior, Live Firings, International Scientific Conference and Industrial forum.

Again, in the Static Display participated armaments and military personnel from and the European Command of the United States Armed Forces. At which were presented three armored infantry fighting vehicles, as well as a close-in unmanned aerial vehicle.

Participation in the Live Firings took nine companies and organizations. During the Live Firings have been demonstrated 24 kinds of new defence products of Bulgarian defence industry manufacturers. The Live Firings were broadcast on live on the Exhibition site, on the Information stands' monitors of in both pavilions.

In the Eleventh International Scientific Conference "Scientific research, technology and innovation - a basis for building new defense capabilities" attended by over 120 delegates and guests from the country and abroad. For the first time this year, the participation in the International Scientific Conference was held not only in physically, but also remotely. More than 60 scientific reports were presented.

As a new accompanying event within Hemus 2022, the day before the official opening of the exhibition, the first Symposium on Research and Innovation for European Security and Defense - Research and Innovation for European Security and Defense (RISE-SD) was opened. The Symposium was attended by more than 30 speakers on projects funded by the European Union, as well as representatives of EDA, Directorate General for Defense Industry and Space (DG DEFIS), European Commission, NATO Science and Technology Organization (NATO STO) and others. The Symposium was a tribune of more than 100 specialists from various European institutes, scientific and business organizations gathered to exchange experiences and establish lasting and useful direct connections.

A new accompanying event was also the DefInSpace Bulgaria 2022 hackathon competition. DefInSpace Bulgaria 2022 is the first international innovation competition with a focus on the application of space technologies in the field of defense and security. It was initiated by the French Space Command in France ( Commandement de l'Espace ) and was organized by the French aerospace cluster "Aerospace Valley" in 2021 and by the Office for Transfer of Aerospace Technologies, Bulgarian Academy of Sciences.

Drawing on the accumulated experience and long tradition, relying on established contacts and business relationships with our partners from the EU, NATO and worldwide, recognizing mutual benefits, we look ahead with optimism to the next International Defence Equipment Exhibition "HEMUS 2024".

The **GENERAL TERMS AND CONDITIONS FOR PARTICIPATION** in the Sixteenth edition of the International Defense Equipment and Services Exhibition „HEMUS 2024“ shall govern the contractual relations between the ORGANIZER and the EXHIBITORS while and in regard to the provision of exhibition areas, construction of stands and bungalows, and the provision of any other services within the framework of „HEMUS 2024“. The General Terms and Conditions shall be deemed acknowledged and approved by the Exhibitors upon signing Form 1 Application for Participation. Any derogation from the General Terms and Conditions has to be agreed upon by and between the ORGANIZER and the EXHIBITOR in writing.

## I. ORGANIZATION.

1. The sixteenth International Defense Equipment and Services Exhibition „HEMUS 2024“ shall be organized under the auspices of the Ministry of Defense and the Ministry of Economy and managed by the Organizing Committee.

2. ORGANIZER of the EXHIBITION is HEMUS-95 FOUNDATION, Plovdiv, with registered office at 116, Hristo Botev Blvd, office 6, 4000 Plovdiv, CIN 825351545, represented by Rear Admiral (Ret.) Nikolay Ivanov Nikolov, PhD, in his capacity of Chairman of the Governing Board.

4. „HEMUS 2024“ is thematically oriented to “Defense, Counterterrorism and Security” with special focus on fields of cybersecurity, border security, strategic communications, autonomous surveillance systems, information and response, artificial intelligence, social media monitoring and analysis of the information contained therein, identification and management of biometric data, combating natural disasters and accidents and protecting the civilian population, as well as educational products in the subject field.

## 5. EVENT DATE AND VENUE.

The sixteenth International Defense Equipment and Services Exhibition „HEMUS 2024“ will be held from June 5 to 8 of the year 2024 on the ground of International Fair Plovdiv AD, Plovdiv.

In case of force majeure or other unforeseen or unforeseeable or unavoidable circumstances of extraordinary nature, or upon order of the competent state authorities or for security reasons, the ORGANIZER may change the dates, duration and working hours without liability for damages resulting from such changes.

Exhibitors shall be notified of such changes either through ORGANIZER’s website: <http://www.hemusbg.org> or by e-mail to the address that each exhibitor has specified in its application for participation. In case the exhibition is postponed, the dates, duration or working time are changed, or the exhibition is cancelled pursuant to the second paragraph of item 5, the EXHIBITOR shall not be entitled to any compensation and all applications submitted as well as all amounts paid prior to such changes shall be deemed submitted or paid for the new dates of the exhibition.

Should the exhibition be interrupted after the official opening for reasons beyond ORGANIZER’s control and/or for the reasons referred to in the second paragraph of item 5 above, and/or due to compelling need to close or evacuate the exhibition area or part thereof either temporarily or for a longer period, the EXHIBITOR may neither cancel their participation, nor claim compensation or reimbursement of any paid amounts.

## II. RIGHT TO PARTICIPATE AND RIGHT OF ACCESS

1. Right to participate in the EXHIBITION shall be granted to all and any Bulgarian and foreign persons (individuals and legal entities) involved in the manufacture or trade activities in compliance to the main subject and the thematic fields, as well as to non-profit organisations that have applied for and received confirmation of participation or have signed a special contract for participation with the ORGANIZER.

# GENERAL TERMS AND CONDITIONS FOR PARTICIPATION

2. Persons with registered offices in embargoed countries designated by the UN, the European Union or the authorities of Republic of Bulgaria may be allowed to participate or granted access to the EXHIBITION subject to a decision depending on the reasons for embargo and at ORGANIZER's discretion.

## 3. EXHIBITORS AND SUB-EXHIBITORS.

3.1. An **EXHIBITOR** is a person entitled to participate in the EXHIBITION and to rent exhibition area and/or purchase services according to these General Terms and Conditions. The EXHIBITOR shall pay a registration fee and may invite a SUB-EXHIBITOR to share the rented exhibition area provided that the EXHIBITOR remains the main person liable jointly with their SUB-EXHIBITOR to pay all amounts due and payable for the whole rented area and the relevant ordered services. The relations between the EXHIBITOR and a SUB-EXHIBITOR may not be opposed to the ORGANIZER and used as an excuse to not pay. It is EXHIBITOR's responsibility to meet ORGANIZER's requirements for the whole rented area jointly with the SUB-EXHIBITOR. The EXHIBITOR may only host a SUBEXHIBITOR after registration of the latter with the ORGANIZER according to these General Terms and Conditions.

3.2. **THE SUB-EXHIBITOR** shall pay a registration fee and enjoy all the rights resulting from such payment. The SUB-EXHIBITOR shall not have their own stand or area and shall use those provided by the EXHIBITOR but has to comply with all of ORGANIZER's requirements. SUB-EXHIBITOR's obligations for rent, construction fee, services, etc. shall be paid to the ORGANIZER by the EXHIBITOR whereas the EXHIBITOR and SUB-EXHIBITOR shall be jointly liable in respect of all payments due to the ORGANIZER.

## 4. VISITORS.

Only officially invited guests shall be granted access to the EXHIBITION on the first day. Access to the EXHIBITION between the second day and the end of the exhibition shall be granted to all professionals, traders and businessmen with invitations or after online pre-registration. Visitors with entry tickets shall only be admitted the last 2 days.

For security reasons, persons under the age of 16 shall only be admitted accompanied by a person who is at least 18 years old and is responsible for their actions.

The **ORGANIZER** reserves the right to deny or terminate the access to the EXHIBITION to any person without providing argumentation. This also applies to the periods of installation and dismantling.

## 5. REGISTRATION AND CONFIRMATION OF PARTICIPATION.

5.1. To participate in the EXHIBITION, each EXHIBITOR shall sign a contract with the ORGANIZER in respect of:

- The present General Terms and Conditions through a written application form (Form 1), which shall only be considered after payment of the registration fee;
- a special contract.

5.2. Unless otherwise provided by a special contract, these General Terms and Conditions shall be mandatory for any EXHIBITOR and SUB-EXHIBITOR and shall be deemed acknowledged and approved upon submission of the application form (Form 1).

5.3. The application for participation (Form 1) must be filled-in and signed by EXHIBITOR's legal representative or an authorised person. Applications with missing required information or that are not signed shall be considered void.

5.4. The EXHIBITOR must register the presence of SUB-EXHIBITOR(S) or other companies at their stand by filling-in the Form for Sub-exhibitor (Form 1B).

5.5. The contract for participation shall be deemed effective upon confirmation of Form 1 by the ORGANIZER; the ORGANIZER or its authorised representative shall then send a set of forms for services, a proforma invoice for the area rental, and a map of exhibition areas. A proforma invoice issued by the ORGANIZER for registration and/or rent fee based on the submitted application for participation shall also be considered a written confirmation.

**5.6.** The deadline for submission of applications is Feb. 29, 2024 (recommended).

**5.7.** THE EXHIBITOR may not sublet or otherwise assign all or part of the exhibition area to third parties without the prior written consent of THE ORGANIZER.

## **6. EXHIBITION AREAS.**

**6.1.** The ORGANIZER and International Fair Plovdiv AD shall allocate exhibition areas taking into consideration the technical characteristics of the event, the industry sector to which the items listed in the application for participation belong, the size of the requested exhibition area and the order of registration of the exhibitors.

**6.2.** In certain cases, for the best interest of the EXHIBITION, the ORGANIZER may change the location, type, dimensions and size of the allocated exhibition area even after confirmation of the application and the EXHIBITOR may not cancel their participation nor seek compensation. The ORGANIZER shall allocate exhibition areas and services taking into account as much as possible exhibitors' requests.

**6.3.** The ORGANIZER is entitled to:

- change the requested area;
- reject the display of items that do not comply with the approved subject sections;
- deny participation without giving argumentation to the party concerned and without being held liable for damages.

## **III. FINANCIAL CONDITIONS AND PAYMENT TERMS**

**1.** EXHIBITORS shall pay the fees for their participation in the EXHIBITION at the rates specified in the application forms for participation, construction and services, in instalments as here follows:

- registration fee: within 3 days following reception of the relevant proforma invoice. In case the registration is not paid, the ORGANIZER may not guarantee booking of the requested area/stand to the EXHIBITOR.
- area rent fee: within 30 days following reception of the relevant proforma invoice but not later than 30 days prior to the opening of the EXHIBITION.
- stand/bungalow construction fee and fees for other services: not later than 10 days prior to the opening of the EXHIBITION.

The fees for services ordered additionally during the EXHIBITION shall be payable within 5 days following the date of the relevant proforma invoice.

**2.** Without consideration to any advance or partial payments made, in case the whole due amount is not paid within the above terms the ORGANIZER may cancel the contract with the EXHIBITOR and retain all paid amounts as compensation for EXHIBITOR's failure to implement these General Terms and Conditions. In such cases, the ORGANIZER may rent the same areas to any third party without compensation for the EXHIBITOR.

**3.** The EXHIBITOR shall pay all instalments by transfer to ORGANIZER's accounts specified in the proforma invoices.

**4.** The ORGANIZER shall provide all basic and additional services as requested through the applications under these General Terms and Conditions via its subsidiary, HEMUS KONSULT EOOD, Plovdiv, with the explicit consent of the EXHIBITORS given by acknowledging and approving these General Terms and Conditions; therefore, all proforma invoices for such services (registration fee, area/stand rent fee, construction fee, etc.) shall be issued on behalf of ORGANIZER's subsidiary HEMUS KONSULT EOOD, Plovdiv, and paid by transfer to their bank account. The subsidiary will perform these services in full compliance with this contract.

The ORGANIZER shall cause the bank account holder specified in the proforma invoices (Hemus Konsult EOOD) to issue a final invoice within three days following reception of the relevant amount.

Amounts due for construction fee and project certification in cases under item 5.2: item 5.2.1. and 5.2.2, from section V, will be invoiced and paid directly to International Fair Plovdiv AD to the bank accounts specified in the invoices, according to the terms of the contract for the construction of exhibition structures.

5. Access of Exhibitors to their respective exhibition areas and/or stands/bungalows will only be granted after advance payment. EXHIBITOR's obligation to pay shall be deemed fulfilled upon reception of any amount due with the bank account specified in item 4 of this Section III.

6. All bank charges shall be for EXHIBITOR's account.

7. Statutory interest shall be charged for each day of delay of payment after the deadlines set in Section III, item 1.

8. The ORGANIZER will be entitled to hold exhibits or other materials owned by the EXHIBITOR until full payment.

9. Upon acquittal of all their financial obligations, EXHIBITORS shall be granted a 'Permit to Leave' allowing them to leave the exhibition areas.

10. EXHIBITORS will be granted the following discounts:

- for early bird registration for participation and payment of at least 50% of the area rent fee and of the fees for all requested services on or before 22.12.2023, EXHIBITORS shall be granted discount amounting 5% of all moneys paid to the exception of the registration fee.

- an EXHIBITOR who orders both indoor and outdoor exhibition areas shall be granted 80% discount of the rental fee for the outdoor exhibition area provided it is at least double the size of the rented indoor area.

- an EXHIBITOR who orders outdoor exhibition area between 21 and 100 square metres shall be granted 25% discount of the rental fee for outdoor areas.

- an EXHIBITOR who orders more than 100 square metres outdoor exhibition area shall be granted 30% discount of the rental fee for outdoor areas.

## 11. REGISTRATION FEE.

Upon payment of the registration fee, the EXHIBITOR and their SUB-EXHIBITOR(S) shall be entitled to the following services:

- Free entry badges for stand staff. Each badge is individual and may not be used by another person;
- 20 invitation cards for visitors to the EXHIBITION that are not valid for the official events organized for EXHIBITORS, and the possibility to pre-register online any visitor that an EXHIBITOR wants to invite to visit their stand;
- Invitation cards to attend the official events organized for exhibitors as follows:
  - 2 cards in case the rented exhibition area is up to 50 sqm;
  - 4 cards in case the rented exhibition area is between 50 and 100 sqm;
  - 6 cards in case the rented exhibition area is between 100 and 200 sqm;
  - 8 cards in case the rented exhibition area is more than 200 sqm.
- Publication of information about the EXHIBITOR and SUB-EXHIBITOR in the printed and online catalogue of the exhibition as specified in these General Terms and Conditions. Regardless of the reasons for termination of the contract or reasons to deny participation to an EXHIBITOR, the ORGANIZER shall not refund the registration fee.

## IV. DENIAL OR TERMINATION OF THE CONTRACT

### 1. Denial of participation or termination of the contract by the ORGANIZER

1.1. The ORGANIZER may, at its own discretion, refuse to confirm the application for participation and deny access to the EXHIBITION to an EXHIBITOR without giving any reason and may not be held liable for damages.

1.2. The ORGANIZER may terminate the contract with an EXHIBITOR with immediate effect after the latter's Application for Participation in the EXHIBITION has already been confirmed if the ORGANIZER has learned new information or circumstances that if it had known from the beginning, would have served as reason to refuse

to confirm the application. In this case, the ORGANIZER terminates the contractual relations with the EXHIBITOR through a written notice, sent to the other party.

**1.3.** The ORGANIZER may terminate the contract with an EXHIBITOR in case the EXHIBITOR fails to comply with these General Terms and Conditions.

**1.4.** The ORGANIZER may withhold amounts paid, offset or claim amounts due by the date of termination of the contract in case it is terminated by EXHIBITOR's fault.

## **2. CANCELLATION OF PARTICIPATION OR TERMINATION OF THE CONTRACT BY THE EXHIBITOR**

**2.1.** The EXHIBITOR may request termination of the Contract in whole or in part by written request addressed to the ORGANIZER and confirmed by the latter, provided there is sufficient well-grounded reason, for which the EXHIBITOR must provide relevant evidence.

**2.2.** Upon such termination of the contract the EXHIBITOR shall pay penalties as follows:

- 20% of the contractual value in the case of termination before 31.01.2024;
- 35% of the contractual value in the case of termination between 01.02.2024 and 01.03.2024;

After 01.03.2024 as well as in case EXHIBITOR's application for participation (Form 1) has been accepted after the deadline for submission of applications the EXHIBITOR shall pay penalty amounting to 50% of the area rental per the approved application along with all cost incurred for providing exhibition service until the time of termination of the contract.

**2.3.** The ORGANIZER may also claim compensation for greater damages.

## **V. TECHNICAL AND SPECIAL CONDITIONS**

### **1. EXHIBITS.**

**1.1.** Within the time limit set in Form 2, each EXHIBITOR shall send to the ORGANIZER a list of their exhibits with general technical information as required to obtain permission for participation from the Organizing committee. Failure to meet this requirement may lead to denial of participation in the Exhibition

**1.2.** Foreign EXHIBITORS must have a permit to participate in exhibitions or a permit for temporary import of goods issued by the Interministerial Commission for Export Control and Non-Proliferation of Weapons of Mass Destruction.

**1.3.** It is not allowed to bring and display explosives or flammable substances within the EXHIBITION ground.

**1.4.** For certain categories of exhibits to be displayed, the EXHIBITOR must declare that they have been deactivated and/or are harmless. Display of radioactive materials that are a threat to human health is forbidden.

**1.5.** EXHIBITORS undertake to keep in a safe place small and valuable items that may be damaged or be taken out of the EXHIBITION ground. The ORGANIZER may not be held liable for any loss or damage of such items, as well as of personal effects of the EXHIBITORS or their staff.

**1.6.** Exhibits will be transported at the expense of the EXHIBITOR. They may be delivered to the exhibition area not earlier than 3 days prior to the opening of the EXHIBITION, unless there are circumstances that require another term, and be displayed on the rented area in accordance with the special instructions contained in the General Terms and Conditions. In exceptional cases, if it is necessary to deliver the exhibits earlier than 3 days prior to the opening of the exhibition, for the storage and protection of their exhibits, the EXHIBITORS should sign additional contracts with the security company chosen by the ORGANIZER, or another such and International Fair Plovdiv AD.

**1.7.** At any time during the exhibition, the ORGANIZER will be entitled to check whether the exhibited products meet the requirements specified in these General Terms and Conditions, as well as the safety requirements in accordance with Bulgarian legislation.

# GENERAL TERMS AND CONDITIONS FOR PARTICIPATION

## 2. WORKING HOURS OF THE EXHIBITION.

**2.1.** After the official opening, the EXHIBITION will be open for professionals with invitations every day from 10:00 to 17:00 and on the last day until 15:00. For EXHIBITORS and the service staff, the EXHIBITION will be open from 9:00 to 18:00.

**2.2.** Outsiders will not be allowed to the territory of International Fair Plovdiv AD outside the specified working hours.

## 3. INSTALLATION AND DISMANTLING.

**3.1.** Installation of stands: between 13 May and 01 June 2024; 24 May is a bank holiday (but a working day for the exhibition);

**3.2.** Arrangement of exhibits: 02 - 04 June 2024;

**3.3.** Disassembly of stands between 16:00 and 20:00 on 08 June 2024 and between 9 and 18 June 2024;

**3.4.** Working hours for installation and dismantling: 08:00 to 17:00. Working hours for arrangement of exhibits: 08:00 to 21:30. As an exception, the ORGANIZER may allow extension of the terms against additional payment according to Form 4.

## 4. AREA RENT.

**4.1.** The ORGANIZER shall provide net indoor and/or outdoor area on the ground of International Fair Plovdiv AD. Each portion of a square metre counts as 1 sqm. Within the area provided there may be structural elements of the pavilion that are not counted in the total area.

**4.2.** If a stand is built on two levels, the rent price for the second level shall be 60% of the rent price for the first level.

**4.3.** The minimum exhibition area that can be rented is:

- for inline stands: 6 sqm;
- for corner stands (two-sides open): 15 sqm
- for three-sides open stands: 24 sqm;
- for four-sides open stands: 60 sqm

**4.4.** The area is rented for a period of 20 calendar days prior to the opening, during the event and 10 days after the closing of the EXHIBITION. The rent price does not cover the building of stands and bungalows, graphic design, staff, materials and other services. Upon EXHIBITOR's written request, they may be provided with corner (two-sides open) or central (three- or four-sides open) net indoor exhibition area against a surcharge of 15% of the area rent price.

**4.5.** All EXHIBITORS who rent indoor exhibition area are required to have a stand built.

**4.6.** Outdoor exhibition structures must be built with a depth of at least 3 m and high wind resistance.

**4.7.** The removal of exhibits and stand materials from the rented exhibition area may start after 16:00 on the closing day of the EXHIBITION.

## 5. CONSTRUCTION.

**5.1.** Construction of stands and bungalows by the ORGANIZER

By order of the EXHIBITOR, the ORGANIZER provides the service of building stands and bungalows with modular aluminum and non-standard construction, as well as unique stands and bungalows. Requests are specified using Form 4. Furnishings, support staff, and other services of the requested stands/bungalows may be requested through Furnishing Order - form 5, which is sent simultaneously with Form 4

**5.2.** Construction of exhibition stands and bungalows by an EXHIBITOR or contractor.

**5.2.1.** Construction fee.

THE EXHIBITOR builds stands and bungalows, either individually or through assignment to another contractor and the relations with INTERNATIONAL FAIR PLOVDIV AD are regulated by a construction contract. In order to cover the total cost of electricity and water, for cleaning the common parts and waste disposal, for using the infrastructure, for overall security and surveillance by the authorized services during the period of assembly and disassembly, the person who builds the stand or the bungalow shall pay a Construction Fee according to Form 4 of the International Fair Plovdiv AD.

## **5.2.2. Project approval.**

All projects for construction and graphic design of the stands/bungalows shall be submitted for approval to International Fair Plovdiv AD, subject to a Project Approval Fee as per Form 4. The technical and financial requirements for them shall be specified in the contract on construction of exhibition structures.

**5.2.3.** THE ORGANIZER is entitled to refuse to sign a Construction Contract with a person, who builds stands, bungalows or provides other services if THE COMPANY or THE EXHIBITOR has outstanding financial obligations to THE ORGANIZER and/or to the International Fair Plovdiv AD or if the projects do not meet the technical requirements and safety conditions.

**5.2.4.** The construction, the artistic layout and the arrangement of the exhibition and advertising areas must be completed within the stipulated workhours the day prior to the opening of event.

**5.2.5.** It is prohibited to make changes to the walls, the floors, the ceilings and other structural elements of the pavilions and the pavement of the open areas except with the written consent of International Fair Plovdiv AD. All damages resulting from the guilty behavior of THE EXHIBITOR/THE CONTRACTOR shall be removed by it or by International Fair Plovdiv AD at the expense of THE EXHIBITOR/THE CONTRACTOR.

**5.2.6.** All power supply from the main switchboards and water supply systems shall be carried out by specialists of International Fair Plovdiv AD and shall be paid for according to Order Form for Electric and Water Connection – Form 10.

**5.2.7.** The Organizer together with the International Fair Plovdiv AD has the exclusive right to grant permission for any kind of lawful activity on the territory of the exhibition area after the conclusion of a contract.

## **6. SECURITY.**

**6.1.** THE ORGANIZER shall provide the general security of the EXHIBITION. To ensure access to the territory of International Fair Plovdiv AD and of the EXHIBITION, the EXHIBITOR shall send to THE ORGANIZER a list of the names of its representatives / stand staff through the Application for Badges for Exhibitors (Form 8). The EXHIBITORS and their staff will not be admitted to the exhibition area after the visiting hours as set out in Section V, Item 2. If the exhibits require special security measures, THE EXHIBITOR may hire security staff only through the ORGANIZER.

**6.2.** Moving exhibits during the opening hours of the EXHIBITION is prohibited. In case exhibited small arms need to be taken out and back into the pavilion, they must be checked by the Military Police Service MoD. Making films and taking photographs of exhibits and stands without the written consent of the ORGANIZER is prohibited.

**6.3.** Vehicles are not allowed to move freely around the ground of International Fair Plovdiv. Parking is allowed only at the designated parking lots with parking passes.

## **7. NON-DISTURBING USE**

**7.1.** The use of rented area should not disturb and interfere with the use of the surrounding stands. When using audio media, the volume must match the overall surrounding sound level and not cause problems to other EXHIBITORS. At any time during the exhibition, THE ORGANIZER may give mandatory instructions to immediately stop using audio without giving reasons and without having to take into consideration the arguments presented by the EXHIBITOR.

**7.2.** EXHIBITORS declare that they will not undertake actions that violate decency, constitute unfair competition or violate copyright and related rights.

## 8. FIRE SAFETY AND OCCUPATIONAL HEALTH AND SAFETY REQUIREMENTS.

**8.1.** The EXHIBITOR must comply and make sure their staff and/or the staff of third-party service providers comply with the occupational health and safety requirements and fire safety requirements; any negative consequences from failure to comply shall be at their expense. It is exhibitor's responsibility to have their staff and equipment insured.

**8.2.** Exhibits are not allowed to drive around the fair ground outside the limits of EXHIBITOR's allocated exhibition area for the duration of the event without ORGANISER's written consent.

**8.3.** For fire safety reasons, each EXHIBITOR must impregnate the stand material with flame retardant coating and produce a certificate proving that the materials are impregnated. Otherwise, the ORGANIZER shall perform the impregnation at the expense of the EXHIBITOR. The EXHIBITOR must provide free access to fire taps and hydrants. The electrical wiring of the stand must comply with the fire applicable safety requirements in the Republic of Bulgaria. It is forbidden to store empty packages and flammable materials at / behind the stand.

## 9. PERSONAL DATA PROTECTION.

**9.1.** As data controller, INTERNATIONAL FAIR PLOVDIV AD shall process and store personal data of EXHIBITORS insofar such data is provided by the exhibitors at the time of submission of their application for participation. Individuals' data that are publicly available as part of a company file, which the exhibitor has made publicly available through the Trade Register kept by the Registry Agency shall be processed by International Fair Plovdiv AD in full compliance with the General Data Protection Regulation and the Privacy and Data Protection Policy of International Fair Plovdiv AD.

**9.2.** Applications for participation in the EXHIBITION only require personal data from EXHIBITORS who are individuals; where the EXHIBITOR is a company, only company data that is publicly available from the REGISTER OF COMPANIES is required.

**9.3.** INTERNATIONAL FAIR PLOVDIV AD does not require or collect information containing personal data of individuals employed by the EXHIBITOR or of their clients, suppliers or individuals related in any way to the EXHIBITOR.

**9.4.** Information that any EXHIBITOR or VISITOR has in any way provided to the International Fair Plovdiv and which is not required and is not subject to storage and processing shall be destroyed in accordance with the applicable rules for the destruction and deletion of personal data.

**9.5.** When conducting marketing research, PLOVDIV INTERNATIONAL FAIR only processes personal data for the purposes of the respective research, and data are collected on the basis of explicit consent upon submission of a confidentiality notice.

**9.6.** Respondents are asked to fill in a questionnaire after they give their informed consent for participation and data processing.

**9.7.** All personal data that INTERNATIONAL FAIR PLOVDIV may obtain in connection with exhibitor's participation to fair event(s) shall be processed in compliance with the applicable legislation only for the specific purposes and on the specified grounds, and they will be transmitted to third parties for processing in order to meet contractual or regulatory obligations, and where the purpose of data collection is direct marketing this shall be done with EXHIBITOR's explicit consent.

## 10. MISCELLANEOUS

**10.1.** Each exhibitor acknowledges and accepts that the exhibits and products that they exhibit may be photographed and filmed before and during the EXHIBITION. Photographs and film material may be used to promote the EXHIBITION. In the event that an EXHIBITOR does not want their trademark, logo, sign, etc. to be used by the ORGANIZER in the materials and events announcing and presenting the EXHIBITION, they must state this in writing until the beginning of the day preceding the opening day of the exhibition.

**10.2.** Each EXHIBITOR agrees for the data submitted by it, such as name, address and registered office, scope of activity, etc. to be published in the printed and online catalogue of THE EXHIBITION.

## **VI. ADDITIONAL SERVICES.**

### **1. PRESS CENTRE.**

The Press Centre of International Fair Plovdiv serves accredited journalists by offering telephone, fax and all that is needed for press conferences, meetings and discussions between journalists and EXHIBITORS.

### **2. DEMONSTRATIONS.**

**2.1.** The ORGANIZER provides opportunities for demonstrations of the exhibits in places designated for that purpose. The exhibitor declares their wish to demonstrate in Form 2B.

**2.2.** Participation of an EXHIBITOR in demonstration shootings organized outside the territory of the INTERNATIONAL FAIR PLOVDIV may be organized by sending the Application for participation in demonstration shootings - Form 2A and the Annex thereto.

### **3. EXHIBITION CATALOGUE AND INFORMATION SYSTEM (IS).**

The organizer and International Fair Plovdiv AD jointly publish a printed and online catalogue of the exhibitors, publish a list of all participants on their websites and maintain an information system for them. The organizer and International Fair Plovdiv AD are not responsible for the accuracy of the data provided by THE EXHIBITOR. The inclusion in the catalogue and in the IS of the address of the company, phone number, fax number, e-mail, website, up to two branches and text information up to 50 characters is obligatory and free of charge for all EXHIBITORS and SUB-EXHIBITORS, the data being taken from the Application for Participation Form (Form 1 or 1B). In case of necessity for change and/or complementing this data, Form 3 – Catalogue and Information System shall be filled in and sent within the specified term. The printing of the trademark (logo) in the printed and online catalogue, the inclusion of more than 2 branches and text information of over 50 characters in the printed catalogue and in IS will be paid for according to Form 3 and is also requested within the specified term.

### **4. PRESENTATIONS, SEMINARS, SYMPOSIUMS.**

The ORGANIZER jointly with International Fair Plovdiv AD provide the EXHIBITORS/the VISITORS with halls and technical equipment for rent for holding presentations, seminars, symposiums, business meetings and other accompanying events. For the purpose, the EXHIBITORS/ the VISITORS conclude a contract with the ORGANIZER by filling in an Application Rental Request Form for Halls and Technical Equipment – Form 7 in writing. The requested events are announced on the websites of the ORGANIZER and INTERNATIONAL FAIR PLOVDIV AD.

### **5. FORWARDING SERVICES.**

**5.1.** The ORGANIZER jointly with International Fair Plovdiv AD perform the following:

- loading and unloading operations (Form 15);
- settlement of customs formalities;
- transport and storage of wrapping and containers;
- transport and storage of exhibits in a warehouse under customs control.

To request transport services, The Transport Services Order – Form 15 may be used.

**5.1.** The EXHIBITOR is not allowed to perform separate loading and unloading of exhibits, as well as access, respectively use of own or rented mechanical means (cranes, forklifts, etc.). The costs for these services are calculated and paid at a special tariff, valid for all international events held on the territory of International Fair Plovdiv AD, which is provided (sent) to the EXHIBITOR upon request.

### **6. INSURANCE.**

The EXHIBITOR bears the risk and responsibility for transport, storage and display of the exhibits and stand material. To guarantee its interests, it must insure its property against any risks during the stay of its property at the EXHIBITION.

### **7. CUSTOMS FORMALITIES.**

Customs clearance of temporary import and export can be done by the specialized service at International Fair Plovdiv AD and/or a forwarding company, authorized by INTERNATIONAL FAIR PLOVDIV AD that are guarantors

to the Customs. Foreign exhibitors must have a Confirmation of their Application for Participation by the ORGANIZER of the EXHIBITION and a Permit for Temporary Export and Re-import or Temporary Admission and Re-export for participation in trade exhibitions, issued by the Interdepartmental Commission for Export Control and Nonproliferation of Weapons of Mass Destruction. The exportation of exhibits under customs control from the exhibition area is only possible with the permission of the customs authorities. In case of nonobservance of this condition, the EXHIBITORS shall be sanctioned by the Customs with the fines, fees and duties envisaged.

## VII. FINAL PROVISIONS

The Bulgarian Substantive Law shall govern the relations between the parties upon the signing of a Contract under these General Terms and Conditions.

All disputes arising between the ORGANIZER and the EXHIBITOR, on the other hand, shall be resolved by negotiation, if necessary, and with the assistance of the FAIR as the MAIN PARTNER.

If no agreement is reached, the dispute shall be referred to the competent Bulgarian court. When distraint of exhibits is necessary, the Bulgarian Civil Procedure Code shall apply.

The ORGANIZER of the exhibition reserves the right to amend or update these General Participation Terms, the forms and rate for which he should publish notification to the exhibitors on the website of the exhibition <http://www.hemusbg.org>, reading the amended general participation terms, forms and rates. In case of amendments / updates, they shall remain effective in their latest version. Amendments or updates may not be made later than 20 calendar days prior to the start of the exhibition.

These General Terms and Conditions are printed in Bulgarian and in English language. The version in Bulgarian language shall be accepted in case of disputes.

In 2024, during the sixteenth edition of the exhibition, the XII International Scientific Conference will be held. The theme of the conference is "Research, innovation and industrial cooperation - a paradigm for adequate defense".

The Eleventh International Scientific Conference was held on 2 and 3 June 2022 as a part of the "Hemus 2022 - Defense, Counterterrorism and Security".

They were attended by: Mr. Orhan Muratli - Director of Operations Support at NATO's NSPA, Mr. Robert Elvish, Head of Air and Land Combat Systems at NATO's NSPA, Colonel Assoc. Prof. D.Sc. Borislav Genov, Director of the Institute of Defense "Prof. Tsvetan Lazarov" and Assoc. Prof. Dr. Velizar Shalamanov from the Institute of Information and Communication Technologies - BAS.

The event was attended by over 120 delegates and guests from the country and abroad - from the Ministry of Defense, Ministry of Economy, Defense Headquarters, Joint Forces Command, Commands of the Armed Forces, the military education system, academia, representatives of Bulgarian and foreign companies and organizations from the defense industry. More than 60 scientific reports were presented.

- To encourage the establishment of contacts and cooperation between Bulgarian and European companies for partnership and participation in the EDF.

## LIVE FIRINGS



The range is certified to carry out range and laboratory tests of small arms, artillery, tank, aviation, anti-aircraft and naval weapons, portable anti-tank and anti-aircraft guided complexes, their ammunition and their components and engineering ammunition in service with the Bulgarian Army, as well as of those produced by the country’s defense industry, as well as newly developed samples of armaments and ammunition by military-scientific and civilian organizations.

Nine companies and organizations took part in the Live Firings within the International Exhibition of Defense Equipment ‘Hemus 2022’. 
## LIVE DEMONSTRATIONS AND STATIC DISPLAY

In case the exhibition is postponed, the dates, duration or working time are changed, or the exhibition is cancelled pursuant to the second paragraph of item 5, the EXHIBITOR shall not be entitled to any compensation and all applications submitted as well as all amounts paid prior to such changes shall be deemed submitted or paid for the new dates of the exhibition.

Should the exhibition be interrupted after the official opening for reasons beyond ORGANIZER's control and/or for the reasons referred to in the second paragraph of item 5 above, and/or due to compelling need to close or evacuate the exhibition area or part thereof either temporarily or for a longer period, the EXHIBITOR may neither cancel their participation, nor claim compensation or reimbursement of any paid amounts.

#### II. RIGHT TO PARTICIPATE AND RIGHT OF ACCESS

1. Right to participate in the EXHIBITION shall be granted to all and any Bulgarian and foreign persons (individuals and legal entities) involved in the manufacture or trade activities in compliance to the main subject and the thematic fields, as well as to non-profit organisations that have applied for and received confirmation of participation or have signed a special contract for participation with the ORGANIZER.

2. Persons with registered offices in embargoed countries designated by the UN, the European Union or the authorities of Republic of Bulgaria may be allowed to participate or granted access to the EXHIBITION subject to a decision depending on the reasons for embargo and at ORGANIZER's discretion.

#### 3. EXHIBITORS AND SUB-EXHIBITORS.

3.1. An EXHIBITOR is a person entitled to participate in the EXHIBITION and to rent exhibition area and/or purchase services according to these General Terms and Conditions. The EXHIBITOR shall

**3.1. ИЗЛОЖИТЕЛЯТ** е лице, което има право да участва в ИЗЛОЖЕНИЕТО и наема изложбена площ и/или услуги по реда на настоящите Общи условия. ИЗЛОЖИТЕЛЯТ заплаща регистрационна такса и има право на собствената си изложбена площ да привлече ПОДИЗЛОЖИТЕЛЯ, при условие, че ИЗЛОЖИТЕЛЯТ е основното задължено лице, солидарно с ПОДИЗЛОЖИТЕЛЯ за заплащане на задълженията, дължими и следващи от цялата наета площ и кореспондиращите с това заявени услуги. Вътрешните отношения между ИЗЛОЖИТЕЛЯ и ПОДИЗЛОЖИТЕЛЯ не могат да бъдат протипоставени на ОРГАНИЗАТОРА и да служат за основание за неплащане. ИЗЛОЖИТЕЛЯТ е отговорен за изпълнение на изискванията на ОРГАНИЗАТОРА за цялата територия на наетата площ, солидарно с ПОДИЗЛОЖИТЕЛЯ. ИЗЛОЖИТЕЛЯТ няма право да приотпява ПОДИЗЛОЖИТЕЛЯ без да го е регистрирал по реда на настоящите Общи условия пред ОРГАНИЗАТОРА.

**3.2. ПОДИЗЛОЖИТЕЛЯТ** заплаща регистрационна такса и се ползва с всички права, произтичащи от заплащането ѝ. ПОДИЗЛОЖИТЕЛЯТ не разполага със собствен щанд и пространство, като ползва това, предоставено му от ИЗЛОЖИТЕЛЯ, но е длъжен да спазва всички изисквания на ОРГАНИЗАТОРА. ОРГАНИЗАТОРЪТ си запазва правото да откаже или да прекрати достъпа до ИЗЛОЖЕНИЕТО на всяко лице без да изтъкне причини. Това се отнася също и за периода на монтаж и демонтаж.

#### 5. РЕГИСТРИРАНЕ И ПОТВЪРЖДАВАНЕ НА УЧАСТИЕТО.

**5.1.** За участие в ИЗЛОЖЕНИЕТО, ИЗЛОЖИТЕЛЯТ сключва договор с ОРГАНИЗАТОРА по: Общите условия за участие чрез писмена заявка по образец (Формуляр1), която се разглежда само след заплащане на регистрационна такса.

- Специален договор.

**5.2.** Общите условия са задължителни за ИЗЛОЖИТЕЛЯ и ПОДИЗЛОЖИТЕЛЯ, освен когато не е предвидено друго в специален договор и се считат за приети с подаването на заявката за участие – Формуляр 1.

**5.3.** Заявката за участие (Формуляр 1) се попълва и подписва от законен представител или упълномощено лице на ИЗЛОЖИТЕЛЯ. Заявка, в която липсват необходимите данни или не е подписана, се счита за невалидна.

**5.4.** ИЗЛОЖИТЕЛЯТ е длъжен да регистрира присъствието на ПОДИЗЛОЖИТЕЛИ и на други фирми на щанда си посредством формуляр за подизложител – Формуляр 1В.

**5.5.** Писменото потвърждение на Формуляр 1 от ОРГАНИЗАТОРА се счита за момента на сключване на договор по Общите условия за участие, след което ОРГАНИЗАТОРЪТ или упълномощено от него лице изпраща комплект формуляри за услуги, проформа-фактура за наем площ и план на изложбените площи. За писмено потвърждение се счита и издадена от ОРГАНИЗАТОРА проформа-фактура за такса регистрация и/или наем въз основа на подадената заявка за участие.

**5.6.** Крайният срок за подаване на заявки е 29.02.2024г. (препоръчителен)

**5.7.** ИЗЛОЖИТЕЛЯТ не може да пренаема или прототстъпва по какъвто и да е начин цялата или част от изложбената площ на трети лица без предварително писмено съгласие на ОРГАНИЗАТОРА.

#### 6. ИЗЛОЖБЕНИ ПЛОЩИ.

**6.1.** Разпределението на изложбените площи се извършва от ОРГАНИЗАТОРА и „Международен панаир Пловдив“ АД, като се вземат предвид техническите характеристики на проявата, браншовата принадлежност на посочените в заявката за участие експонати, размера на заявената изложбена площ и по реда на регистрирането на изложителите.

**6.3.** ОРГАНИЗАТОРЪТ има право:

- да променя заявената площ;
- да откаже излагането на експонати, несъответстващи на утвърдените тематични направления;
- да откаже участие без да е необходимо да мотивира действията си пред съответната страна и без да носи финансова отговорност за претърпени вреди.

#### III. ФИНАНСОВИ УСЛОВИЯ И СРОКОВЕ НА ПЛАЩАНЕ

**1.** ИЗЛОЖИТЕЛЯТ заплаща участието си в ИЗЛОЖЕНИЕТО, съгласно тарифите, посочени във формулярите за участие, изграждане и услуги, на вноски както следва:

регистрационна такса - в срок до 3 дни от изпращане на проформа-фактура. При неплатена регистрационна такса ОРГАНИЗАТОРЪТ не гарантира на ИЗЛОЖИТЕЛЯ запазване на заявената площ/щанд.

наем на площ – в срок от 30 дни от датата на получаване на проформа-фактурата, но не по-късно от 30 дни преди откриване на ИЗЛОЖЕНИЕТО.

изграждане на щандове и бунгала и други услуги – не по-късно от 10 дни преди откриване на ИЗЛОЖЕНИЕТО.

Допълнително поръчани услуги по време на ИЗЛОЖЕНИЕТО се заплащат в 5-дневен срок от издаване на проформа-фактурата.

pay a registration fee and may invite a SUB-EXHIBITOR to share the rented exhibition area provided that the EXHIBITOR remains the main person liable jointly with their SUB-EXHIBITOR to pay all amounts due and payable for the whole rented area and the relevant ordered services. The relations between the EXHIBITOR and a SUB-EXHIBITOR may not be opposed to the ORGANIZER and used as an excuse to not pay. It is EXHIBITOR's responsibility to meet ORGANIZER's requirements for the whole rented area jointly with the SUB-EXHIBITOR. The EXHIBITOR may only host a SUBEXHIBITOR after registration of the latter with the ORGANIZER according to these General Terms and Conditions.

**3.2. THE SUB-EXHIBITOR** shall pay a registration fee and enjoy all the rights resulting from such payment. The SUB-EXHIBITOR shall not have their own stand or area and shall use those provided by the EXHIBITOR but has to comply with all of ORGANIZER's requirements. SUB-EXHIBITOR's obligations for rent, construction fee, services, etc. shall be paid to the ORGANIZER by the EXHIBITOR whereas the EXHIBITOR and SUB-EXHIBITOR shall be jointly liable in respect of all payments due to the ORGANIZER.

#### 4. VISITORS.

Only officially invited guests shall be granted access to the EXHIBITION on the first day. Access to the EXHIBITION between the second day and the end of the exhibition shall be granted to all professionals, traders and businessmen with invitations or after online pre-registration. Visitors with entry tickets shall only be admitted the last 2 days.

For security reasons, persons under the age of 16 shall only be admitted accompanied by a person who is at least 18 years old and is responsible for their actions.

The ORGANIZER reserves the right to deny or terminate the access to the EXHIBITION to any person without providing argumentation. This also applies to the periods of installation and dismantling.

#### 5. REGISTRATION AND CONFIRMATION OF PARTICIPATION.

**5.1.** To participate in the EXHIBITION, each EXHIBITOR shall sign a contract with the ORGANIZER in respect of:

- The present General Terms and Conditions through a written application form (Form 1), which shall only be considered after payment of the registration fee;
- a special contract.

**5.2.** Unless otherwise provided by a special contract, these General Terms and Conditions shall be mandatory for any EXHIBITOR and SUB-EXHIBITOR and shall be deemed acknowledged and approved upon submission of the application form (Form 1).

**5.3.** The application for participation (Form 1) must be filled-in and signed by EXHIBITOR's legal representative or an authorised person. Applications with missing required information or that are not signed shall be considered void.

**5.4.** The EXHIBITOR must register the presence of SUB-EXHIBITOR(S) or other companies at their stand by filling-in the Form for Sub-exhibitor (Form 1B).

**5.5.** The contract for participation shall be deemed effective upon confirmation of Form 1 by the ORGANIZER; the ORGANIZER or its authorised representative shall then send a set of forms for services, a proforma invoice for the area rental, and a map of exhibition areas. A proforma invoice issued by the ORGANIZER for registration and/or rent fee based on the submitted application for participation shall also be considered a written confirmation.

**5.6.** The deadline for submission of applications is Feb. 29, 2022 (recommended).

**5.7.** THE EXHIBITOR may not sublet or otherwise assign all or part of the exhibition area to third parties without the prior written consent of THE ORGANIZER.

#### 6. EXHIBITION AREAS.

**6.1.** The ORGANIZER and International Fair Plovdiv AD shall allocate exhibition areas taking into consideration the technical characteristics of the event, the industry sector to which the items listed in the application for participation belong, the size of the requested exhibition area and the order of registration of the exhibitors.

**6.2.** In certain cases, for the best interest of the EXHIBITION, the ORGANIZER may change the location, type, dimensions and size of the allocated exhibition area even after confirmation of the application and the EXHIBITOR may not cancel their participation nor seek compensation. The ORGANIZER shall allocate exhibition areas and services taking into account as much as possible exhibitors' requests.

**6.3.** The ORGANIZER is entitled to:

- change the requested area;
- reject the display of items that do not comply with the approved subject sections;
- deny participation without giving argumentation to the party concerned and without being held liable for damages.

#### III. FINANCIAL CONDITIONS AND PAYMENT TERMS

**1.** EXHIBITORS shall pay the fees for their participation in the EXHIBITION at the rates specified in the application forms for participation, construction and services, in instalments as here follows:

registration fee: within 3 days following reception of the relevant proforma invoice. In case the registration is not paid, the ORGANIZER may not guarantee booking of the requested area/stand to the EXHIBITOR.

area rent fee: within 30 days following reception of the relevant proforma invoice but not later than 30 days prior to the opening of the EXHIBITION.

stand/bungalow construction fee and fees for other services: not later than 10 days prior to the opening of the EXHIBITION.

The fees for services ordered additionally during the EXHIBITION shall be payable within 5 days following the date of the relevant proforma invoice.

2. Независимо от направените авансови или частични плащания, ОРГАНИЗАТОРЪТ, в случай на неплащане на цялата дължима сума в сроковете посочени по-горе, може да прекрати договора с ИЗЛОЖИТЕЛЯ и задържи всички платени вече суми като обезщетение за неизпълнението на Общите условия от ИЗЛОЖИТЕЛЯ. В този случай ОРГАНИЗАТОРЪТ има право да предостави същите площи на трети лица, без да дължи обезщетение на ИЗЛОЖИТЕЛЯ.

3. **ИЗЛОЖИТЕЛЯТ** заплаща вноските на ОРГАНИЗАТОРА по сметки, посочени в проформа-фактурите.

4. Всички основни и допълнителни услуги по заявките на изложителите към тези общи условия, ОРГАНИЗАТОРЪТ на изложението ще предоставя чрез дъщерното си дружество – „ХЕМУС КОНСУЛТ“ ЕООД гр. Пловдив, за което с приемането на тези общи условия, ИЗЛОЖИТЕЛИТЕ дават изричното си съгласие, поради което всички проформа-фактури за тези услуги (регистрационна такса, наем площ/шанг, и др.п.) се издават от името и за сметка на дъщерното дружество на ОРГАНИЗАТОРА – „ХЕМУС КОНСУЛТ“ ЕООД гр. Пловдив и съответно се заплащат по негова сметка. Дъщерното дружество ще изпълнява тези услуги в пълно съответствие с тези общи условия.

ОРГАНИЗАТОРЪТ, чрез посочения в проформа-фактурата титуляр на сметката („Хемус Консулт“ ЕООД), издава фактура в 3-дневен срок от получаване на сумата.

Дължимите суми за строителна такса и заверка на проект в случаите по т.5.2: т. 5.2.1. и 5.2.2, от раздел V, се фактурират и заплащат директно на Международен панаир Пловдив АД по посочената във фактурите банкови сметки съгласно условията на договор за изграждане на изложбени конструкции.

5. Изложбените площи и изградените шандове и/или бунгала се предоставят на изложителите само след предварително заплащане. Задължението за плащане на ИЗЛОЖИТЕЛЯ се счита за изпълнено в деня на получаване на дължимата сума по сметката посочена в т.4 по-горе от този раздел III.

6. Комисионите по банковите преводи са за сметка на ИЗЛОЖИТЕЛЯ.

7. За всеки просрочен ден на плащане след сроковете от р. III, т.1 се начислява законната лихва.

8. ОРГАНИЗАТОРЪТ има право да задържи експонати и други материали на ИЗЛОЖИТЕЛЯ до пълно уреждане на плащането.

9. След уреждане на финансовите си задължения ИЗЛОЖИТЕЛЯТ получава „Разрешение за напускане“, което му позволява да напусне изложбените площи.

10. На ИЗЛОЖИТЕЛИТЕ се предоставят следните отстъпки:

- при ранна регистрация за участие до 22.12.2023г. включително и заплащане на минимум 50% от наемната цена и заявените услуги в рамките на същия период, ИЗЛОЖИТЕЛЯТ получава 5% отстъпка от платената стойност с изключение на таксата за регистрация.

- при заявяване на открита площ над 100 кв.м. ИЗЛОЖИТЕЛЯТ получава 30% отстъпка от наемната цена за открита площ.

#### 11. РЕГИСТРАЦИОННА ТАКСА.

С плащането на регистрационна такса за ИЗЛОЖИТЕЛЯ и ПОДИЗЛОЖИТЕЛЯ се поражда право на следните услуги:

- безплатни входни карти за лица, работещи на шандовете. Входната карта е индивидуална и не може да бъде предоставяна на друго лице;

- 4 бр. при наета изложбена площ от 50 до 100 кв. м.
- 6 бр. при наета изложбена площ от 100 до 200 кв. м.
- 8 бр. при наета изложбена площ над 200 кв. м.

- публикуване на информация за ИЗЛОЖИТЕЛЯ и ПОДИЗЛОЖИТЕЛЯ в книжния и онлайн каталог на изложението така, както е посочено в настоящите Общи условия. Независимо от причините за прекратяване на договора или отказ за участие на ИЗЛОЖИТЕЛЯ, ОРГАНИЗАТОРЪТ не дължи връщане на регистрационната такса.

#### IV. ОТКАЗ ИЛИ ПРЕКРАТЯВАНЕ НА ДОГОВОРА

1. Отказ от участие или прекратяване на договора от страна на ОРГАНИЗАТОРА.  
1.1. ОРГАНИЗАТОРЪТ, съобразно собствена преценка, може да откаже да потвърди заявка за участие на ИЗЛОЖИТЕЛЯ и да откаже да го допусне до ИЗЛОЖЕНИЕТО, без да е необходимо да представя аргументи за това и без да носи отговорност за вреди.  
1.2. ОРГАНИЗАТОРЪТ може да прекрати незабавно договора с ИЗЛОЖИТЕЛЯ, след като вече е потвърдена заявката за участие в ИЗЛОЖЕНИЕТО, ако е узнал нови данни или обстоятелства, които ако е знаел от самото начало, биха послужили за отказ да се потвърди заявката за участие. В този случай ОРГАНИЗАТОРЪТ прекратява договорните отношения с ИЗЛОЖИТЕЛЯ посредством писмено известие, изпратено до насрещната страна.

2. Without consideration to any advance or partial payments made, in case the whole due amount is not paid within the above terms the ORGANIZER may cancel the contract with the EXHIBITOR and retain all paid amounts as compensation for EXHIBITOR's failure to implement these General Terms and Conditions. In such cases, the ORGANIZER may rent the same areas to any third party without compensation for the EXHIBITOR.

3. **The EXHIBITOR** shall pay all instalments by transfer to ORGANIZER's accounts specified in the proforma invoices.

4. **The ORGANIZER** shall provide all basic and additional services as requested through the applications under these General Terms and Conditions via its subsidiary, HEMUS KONSULT EOOD, Plovdiv, with the explicit consent of the EXHIBITORS given by acknowledging and approving these General Terms and Conditions; therefore, all proforma invoices for such services (registration fee, area/stand rent fee, construction fee, etc.) shall be issued on behalf of ORGANIZER's subsidiary HEMUS KONSULT EOOD, Plovdiv, and paid by transfer to their bank account. The subsidiary will perform these services in full compliance with this contract.

The ORGANIZER shall cause the bank account holder specified in the proforma invoices (Hemus Konsult EOOD) to issue a final invoice within three days following reception of the relevant amount.

Amounts due for construction fee and project certification in cases under item 5.2: item 5.2.1. and 5.2.2, from section V, will be invoiced and paid directly to International Fair Plovdiv AD to the bank accounts specified in the invoices, according to the terms of the contract for the construction of exhibition structures.

5. Access of Exhibitors to their respective exhibition areas and/or stands/bungalows will only be granted after advance payment. EXHIBITOR's obligation to pay shall be deemed fulfilled upon reception of any amount due with the bank account specified in item 4 of this Section III.

6. All bank charges shall be for EXHIBITOR's account.

7. Statutory interest shall be charged for each day of delay of payment after the deadlines set in Section III, item 1.

8. The ORGANIZER will be entitled to hold exhibits or other materials owned by the EXHIBITOR until full payment.

9. Upon acquittal of all their financial obligations, EXHIBITORS shall be granted a 'Permit to Leave' allowing them to leave the exhibition areas.

10. EXHIBITORS will be granted the following discounts:

- for early bird registration for participation and payment of at least 50% of the area rent fee and of the fees for all requested services on or before 22.12.2023, EXHIBITORS shall be granted discount amounting 5% of all moneys paid to the exception of the rental fee.

- an EXHIBITOR who orders both indoor and outdoor exhibition areas shall be granted 80% discount of the rental fee for the outdoor exhibition area provided it is at least double the size of the rented indoor area.

- an EXHIBITOR who orders outdoor exhibition area between 21 and 100 square metres shall be granted 25% discount of the rental fee for outdoor areas.

- an EXHIBITOR who orders more than 100 square metres outdoor exhibition area shall be granted 30% discount of the rental fee for outdoor areas.

#### 11. REGISTRATION FEE.

Upon payment of the registration fee, the EXHIBITOR and their SUB-EXHIBITOR(S) shall be entitled to the following services:

- Free entry badges for stand staff. Each badge is individual and may not be used by another person;  
- 20 invitation cards for visitors to the EXHIBITION that are not valid for the official events organized for EXHIBITORS, and the possibility to pre-register online any visitor that an EXHIBITOR wants to invite to visit their stand;

- Invitation cards to attend the official events organized for exhibitors as follows:

- 2 cards in case the rented exhibition area is up to 50 sqm;
- 4 cards in case the rented exhibition area is between 50 and 100 sqm;
- 6 cards in case the rented exhibition area is between 100 and 200 sqm;
- 8 cards in case the rented exhibition area is more than 200 sqm.

- Publication of information about the EXHIBITOR and SUB-EXHIBITOR in the printed and online catalogue of the exhibition as specified in these General Terms and Conditions. Regardless of the reasons for termination of the contract or reasons to deny participation to an EXHIBITOR, the ORGANIZER shall not refund the registration fee.

#### IV. DENIAL OR TERMINATION OF THE CONTRACT

1. Denial of participation or termination of the contract by the ORGANIZER

1.1. The ORGANIZER may, at its own discretion, refuse to confirm the application for participation and deny access to the EXHIBITION to an EXHIBITOR without giving any reason and may not be held liable for damages.

1.2. The ORGANIZER may terminate the contract with an EXHIBITOR with immediate effect after the latter's Application for Participation in the EXHIBITION has already been confirmed if the ORGANIZER has learned new information or circumstances that if it had known from the beginning, would have served as reason to refuse to confirm the application. In this case, the ORGANIZER terminates the contractual relations with the EXHIBITOR through a written notice, sent to the other party.

**1.3. ОРГАНИЗАТОРЪТ** може да прекрати договора с ИЗЛОЖИТЕЛЯ, в случай на неизпълнение на Общите условия от страна на ИЗЛОЖИТЕЛЯ.

**1.4. ОРГАНИЗАТОРЪТ** има право да задържи платени суми, да приспадне или да претендира такива, дължими към датата на прекратяване на договора, когато това е станало по вина на ИЗЛОЖИТЕЛЯ.

**2. ОТКАЗ ОТ УЧАСТИЕ ИЛИ ПРЕКРАТЯВАНЕ НА ДОГОВОРА ОТ СТРАНА НА ИЗЛОЖИТЕЛЯ.**

**2.1. ИЗЛОЖИТЕЛЯТ** може да поиска прекратяване изцяло или частично на договора с писмено искане, отправено до ОРГАНИЗАТОРА и потвърдено от него, при наличие на достатъчно обоснована причина, за която следва да представи съответните доказателства.

**2.2. При прекратяване на договора ИЗЛОЖИТЕЛЯТ** дължи следните неустойки:

- 20% от стойността на договора при прекратяване направено до 31.01.2024 г.
- 35% от стойността на договора при прекратяване направено от 01.02.2024 г. до 01.03.2024 г.

След 01.03.2024 г. както и в случаите, когато заявката за участие – Формуляр 1 на ИЗЛОЖИТЕЛЯ е приета по изключение извън крайния срок за подаване на заявки, същият заплаща неустойка в размер на 50% от стойността на наема на потвърдената заявка и пълно заплащане на направените до момента на прекратяване на договора разходи по осигуряване на изложбени услуги.

**2.3. ОРГАНИЗАТОРЪТ** може да иска обезщетение и за по-големи вреди.

**V. ТЕХНИЧЕСКИ И СПЕЦИАЛНИ УСЛОВИЯ**

**1. ЕКСПОНАТИ.**

**1.1. ИЗЛОЖИТЕЛИТЕ** трябва да изпратят на ОРГАНИЗАТОРА в посочения във Формуляр 2 срок, списък и общотехническа информация за излаганите експонати, необходими за издаване на разрешение за участие от Организационния комитет. Неспазването на това изискване може да доведе до отказ за участие в Изложбата.

**1.2. Чуждестранните ИЗЛОЖИТЕЛИ** трябва да имат разрешение за участие в изложения или разрешение за временен внос на стоки, издадено от Междуправителствена комисия за експортен контрол и неразпространение на оръжия за масово унищожаване.

**1.3. Не се разрешава** внасянето и излагането на територията на ИЗЛОЖЕНИЕТО на експлозивни и лесно запалими вещества.

**1.4. За определени категории експонати ИЗЛОЖИТЕЛИТЕ** се задължават да декларират, че същите са дезактивирани и/или са безвредни, за да могат да бъдат изложени. Не е разрешено излагането на радиоактивни материали, застрашаващи здравето на хората.

**1.5. ИЗЛОЖИТЕЛИТЕ** се задължават да пазят на сигурно място малките и ценни изделия, които могат да бъдат повредени или е възможно да бъдат изнесени извън територията на ИЗЛОЖЕНИЕТО. ОРГАНИЗАТОРЪТ не поема отговорността за загуби и щети, нанесени на горните предмети, както и на лични вещи на ИЗЛОЖИТЕЛИТЕ или техния персонал.

**1.6. Експонатите** се транспортират за сметка на ИЗЛОЖИТЕЛЯ. Те могат да бъдат доставени на изложбената площ не по-рано от 3 дни преди откриването на ИЗЛОЖЕНИЕТО, ако обстоятелствата не налагат друг срок и да бъдат изложени на наемната площ, като се спазват специалните инструкции, упоменати в Общите условия за участие. В изключителни случаи, ако се налага експонатите да бъдат доставени по-рано от 3 дни преди откриването на изложението, за съхранение и охрана на своите експонати, ИЗЛОЖИТЕЛИТЕ следва да сключат допълнителни договори с избраното от ОРГАНИЗАТОРА дружество за охрана, или друго такова и Международен Панаир Пловдив АД.

**1.7. По всяко време** на изложбата ОРГАНИЗАТОРЪТ има право да проверява дали изложените продукти отговарят на изискванията посочени в настоящите общи условия, както и на изисквания за безопасност съобразно българското законодателство.

**2. РАБОТНО ВРЕМЕ НА ИЗЛОЖЕНИЕТО.**

**2.1. След официалното откриване,** ИЗЛОЖЕНИЕТО е отворено за специалисти с покани всеки ден от 10.00 до 17.00 ч., а в последния ден до 15.00 ч. За ИЗЛОЖИТЕЛИТЕ и обслужващия персонал ИЗЛОЖЕНИЕТО е отворено от 9.00 до 18.00 часа.

**2.2. Извън посоченото работно време,** външни лица на територията на „Международен панаир Пловдив“ АД не сепускат.

**3. МОНТАЖ И ДЕМОНТАЖ.**

**3.1. Монтаж на щандове** – от 13 май до 01 юни 2024г.; 24 май – официален празник (работен ден за изложението);

**3.2. Разполагане на експонати** - от 02 до 04 юни 2024 г.;

**3.3. Демонтаж на щандове** - от 16.00 до 20.00 ч. на 8 юни 2024 г. и от 9 до 18 юни 2024 г.;

**3.4. Работното време на монтажа и демонтажа** е от 8.00 до 17.00 часа. Работното време за разполагане на експонати е от 8.00 до 21:30 часа. По изключение, ОРГАНИЗАТОРЪТ може да разреши удължаване на сроковете срещу заплащане, съгласно Формуляр 4.

**4. НАЕМ ПЛОЩ.**

**4.1. ОРГАНИЗАТОРЪТ** предоставя нето покрита и/или открита изложбена площ на територията на „Международен панаир Пловдив“ АД. Всеки започнат квадратен метър се счита за 1 кв.м. В рамките на предоставената площ може да има конструктивни елементи на палатата, които не се начисляват в количеството на тази площ.

**4.2. Ако конструкцията на щанда** е на два етажа, за втория етаж се заплаща наем площ в размер на 60% от наема на площта за първия етаж.

**4.3. Минималната изложбена площ,** която може да бъде наета, е:

- линейна – 6 кв.м.

**1.3. The ORGANIZER** may terminate the contract with an EXHIBITOR in case the EXHIBITOR fails to comply with these General Terms and Conditions.

**1.4. The ORGANIZER** may withhold amounts paid, offset or claim amounts due by the date of termination of the contract in case it is terminated by EXHIBITOR's fault.

**2. CANCELLATION OF PARTICIPATION OR TERMINATION OF THE CONTRACT BY THE EXHIBITOR**

**2.1. The EXHIBITOR** may request termination of the Contract in whole or in part by written request addressed to the ORGANIZER and confirmed by the latter, provided there is sufficient well-grounded reason, for which the EXHIBITOR must provide relevant evidence.

**2.2. Upon such termination of the contract the EXHIBITOR** shall pay penalties as follows:

- 20% of the contractual value in the case of termination before 31.01.2024;
- 35% of the contractual value in the case of termination between 01.02.2024 and 01.03.2024;

After 01.03.2024 as well as in case EXHIBITOR's application for participation (Form 1) has been accepted after the deadline for submission of applications the EXHIBITOR shall pay penalty amounting to 50% of the area rental per the approved application along with all cost incurred for providing exhibition service until the time of termination of the contract.

**2.3. The ORGANIZER** may also claim compensation for greater damages.

**V. TECHNICAL AND SPECIAL CONDITIONS**

**1. EXHIBITS.**

**1.1. Within the time limit set in Form 2,** each EXHIBITOR shall send to the ORGANIZER a list of their exhibits with general technical information as required to obtain permission for participation from the Organizing committee. Failure to meet this requirement may lead to denial of participation in the Exhibition

**1.2. Foreign EXHIBITORS** must have a permit to participate in exhibitions or a permit for temporary import of goods issued by the Interministerial Commission for Export Control and Non-Proliferation of Weapons of Mass Destruction.

**1.3. It is not allowed** to bring and display explosives or flammable substances within the EXHIBITION ground.

**1.4. For certain categories of exhibits to be displayed,** the EXHIBITOR must declare that they have been deactivated and/or are harmless. Display of radioactive materials that are a threat to human health is forbidden.

**1.5. EXHIBITORS** undertake to keep in a safe place small and valuable items that may be damaged or be taken out of the EXHIBITION ground. The ORGANIZER may not be held liable for any loss or damage of such items, as well as of personal effects of the EXHIBITORS or their staff.

**1.6. Exhibits** will be transported at the expense of the EXHIBITOR. They may be delivered to the exhibition area not earlier than 3 days prior to the opening of the EXHIBITION, unless there are circumstances that require another term, and be displayed on the rented area in accordance with the special instructions contained in the General Terms and Conditions. In exceptional cases, if it is necessary to deliver the exhibits earlier than 3 days prior to the opening of the exhibition, for the storage and protection of their exhibits, the EXHIBITORS should sign additional contracts with the security company chosen by the ORGANIZER, or another such and International Fair Plovdiv AD.

**1.7. At any time during the exhibition,** the ORGANIZER will be entitled to check whether the exhibited products meet the requirements specified in these General Terms and Conditions, as well as the safety requirements in accordance with Bulgarian legislation.

**2. WORKING HOURS OF THE EXHIBITION.**

**2.1. After the official opening,** the EXHIBITION will be open for professionals with invitations every day from 10:00 to 17:00 and on the last day until 15:00. For EXHIBITORS and the service staff, the EXHIBITION will be open from 9:00 to 18:00.

**2.2. Outsiders** will not be allowed to the territory of International Fair Plovdiv AD outside the specified working hours.

**3. INSTALLATION AND DISMANTLING.**

**3.1. Installation of stands:** between 13 and 01 June 2024; 24 May is a bank holiday (but a working day for the exhibition);

**3.2. Arrangement of exhibits:** 02 - 04 June 2024;

**3.3. Disassembly of stands** between 16:00 and 20:00 on 08 June 2024 and between 9 and 18 June 2024;

**3.4. Working hours for installation and dismantling:** 08:00 to 17:00. Working hours for arrangement of exhibits: 08:00 to 21:30. As an exception, the ORGANIZER may allow extension of the terms against additional payment according to Form 4.

**4. AREA RENT.**

**4.1. The ORGANIZER** shall provide net indoor and/or outdoor area on the ground of International Fair Plovdiv AD. Each portion of a square metre counts as 1 sqm. Within the area provided there may be structural elements of the pavilion that are not counted in the total area.

**4.2. If a stand is built on two levels,** the rent price for the second level shall be 60% of the rent price for the first level.

**4.3. The minimum exhibition area that can be rented is:**

- for inline stands: 6 sqm;

- ъглова (двустранно отворена) – 15 кв.м.
- тристранно отворена – 24 кв.м.
- четиристранно отворена – 60 кв.м.

**4.4.** Наемането на площта се отнася за период от 20 календарни дни преди откриването, по време на провеждането и 10 дни след закриването на ИЗЛОЖЕНИЕТО. Наемът на площ не включва изграждането на щандове и бунгала, художественото оформление, персонал, материали и други услуги. По писмена заявка на ИЗЛОЖИТЕЛЯ, може да му бъде предоставена ъглова (двустранно отворена) или централна (три- и четиристранно отворена) нето покрита изложбена площ срещу надценка от 15% от наема за площта.

**4.5.** Оформянето на щанд на цялата покрита изложбена площ е задължително за всички ИЗЛОЖИТЕЛИ.

**4.6.** Изложбени конструкции на открито задължително се изграждат с дълбочина минимум 3 м, добре укрепени срещу вятър.

**4.7.** Наематата изложбена площ може да започне да се освобождава от експонатите и щандов материал след 16.00ч. в деня на закриване на ИЗЛОЖЕНИЕТО.

#### **5. ИЗГРАЖДАНЕ.**

**5.1.** Изграждане на щандове и бунгала от ОРГАНИЗАТОРА.

По поръчка на ИЗЛОЖИТЕЛЯ, ОРГАНИЗАТОРЪТ предоставя услугата изграждане на щандове и бунгала с модулна алуминиева и с нестандартна конструкция, както и уникални щандове и бунгала. Заявките се конкретизират чрез Формуляр 4. Обзаваждане, помощен персонал и други услуги на заявените щандове/бунгала се заявява чрез Поръчка за обаваждане – формуляр 5, който се изпраща едновременно с Формуляр 4

**5.2.** Изграждане на щандове и бунгала от ИЗЛОЖИТЕЛЯ или изпълнителя.

**5.2.1.** Строителна такса.

ИЗЛОЖИТЕЛЯТ изгражда щандове и бунгала самостоятелно или чрез възлагане на друг изпълнител, като отношенията с Международен Панаир Пловдив АД се регламентират с договор за изграждане. С оглед покриване на общите разходи за ел. енергия и вода, за почистване на общите части и извозване на отпадъци, за ползване на инфраструктурата, за обща охрана и наблюдение от упълномощените служби през монтажния и демонтажния период, лицето, което изгражда щанда или бунгалото заплаща строителна такса съгласно Формуляр 4 на Международен Панаир Пловдив АД.

**5.2.2.** Заверка на проект.

Проектите за изграждане и оформление на щандовете/бунгалата се предоставят задължително за съгласуване с „Международен панаир Пловдив“ АД, като се заплаща такса заверка на проект на „Международен Панаир Пловдив“ АД, съгласно Формуляр 4. Техническите и финансови изисквания към тях са посочени в договора за изграждане на изложбени конструкции.

**5.2.3.** ОРГАНИЗАТОРЪТ има право да откаже сключването на договор за изграждане с лице, което изгражда щандове, бунгала или извършва други услуги, ако ФИРМАТА или ИЗЛОЖИТЕЛЯТ имат неизплатени финансови задължения към ОРГАНИЗАТОРА и/или „Международен Панаир Пловдив“ АД или ако проектите не отговарят на техническите изисквания и условия за безопасност.

**5.2.4.** Изграждането, художественото оформление и аранжирането на изложбените и рекламните площи трябва да бъдат завършени в рамките на регламентираното работно време в деня преди откриването на проявата.

**5.2.5.** Забранява се извършването на промени по стените, поделите, таваните и други конструктивни елементи на палатите и настилката на откритите площи, освен с писменото съгласие на „Международен панаир Пловдив“ АД. Всички щети, произтекли от виновно поведение на ИЗЛОЖИТЕЛЯ/ИЗПЪЛНИТЕЛЯ се отстраняват от него или от „Международен панаир Пловдив“ АД за сметка на ИЗЛОЖИТЕЛЯ/ИЗПЪЛНИТЕЛЯ.

**5.2.6.** Всички захранвания от главните ел. табла и ВиК се извършват от специалисти на „Международен панаир Пловдив“ АД и се заплащат съгласно Формуляр 10.

**5.2.7.** ОРГАНИЗАТОРЪТ съвместно с „Международен панаир Пловдив“ АД имат изключително право да предоставят разрешение за всякакъв вид законосъобразна дейност на територията на изложбените площи след сключване на договор.

#### **6. ОХРАНА.**

**6.1.** ОРГАНИЗАТОРЪТ осигурява общата охрана на Изложението. За осигуряване на достъп до територията на „Международен панаир Пловдив“ АД и на ИЗЛОЖЕНИЕТО ИЗЛОЖИТЕЛЯТ изпраща на ОРГАНИЗАТОРА имената на своите представители/служители на щандове чрез Заявка за входни карти за изложители – Формуляр 8. ИЗЛОЖИТЕЛИТЕ и техният персонал няма да бъдат допускани в изложбените площи след часовете за посещения, определени в р.в. т. 2. Ако експонатите се нуждаят от специални охранителни мерки по време на изложението, ИЗЛОЖИТЕЛЯТ може да наеме охранителен персонал единствено чрез ОРГАНИЗАТОРА.

**6.2.** Забранява се преместването на експонати през часовете, в които е отворена ИЗЛОЖЕНИЕТО. Ако се налага изяснение и внасяне в палатата на леко стрелково оръжие, което е експонирано, същото задължително се проверява от Служба Военна полиция – МО. Правенето на филми и фотографии на експонати и щандове без писменото разрешение на ОРГАНИЗАТОРА е забранено.

**6.3.** Забранява се свободното движение на автомобили на територията на Международен панаир Пловдив. Паркирането се извършва само на изрично определените за целта места срещу пропуски за паркиране.

#### **7. НЕОБЕЗОПКОЯВАЩО ПОЛЗВАНЕ.**

**7.1.** Ползването на предоставеното под наем пространство не трябва да смущава и пречи на използването на заобикалящите го щандове. При използване на озвучени материали, силата на звука следва да отговаря на общия звуков фон и да не създава проблеми на другите ИЗЛОЖИТЕЛИ. По всяко време на изложението ОРГАНИЗАТОРЪТ може да гледа задължителни указания за незабавно спиране на съответното озвучаване, без да е необходимо да се мотивира и без да е необходимо да се съобразява с представените от ИЗЛОЖИТЕЛЯ договори.

**7.2.** ИЗЛОЖИТЕЛИТЕ декларират, че няма да предприемат действия, които да нарушават добрите нрави, да представляват неолойна конкуренция или да нарушават авторски и сродни права.

- for corner stands (two-sides open): 15 sqm
- for three-sides open stands: 24 sqm;
- for four-sides open stands: 60 sqm

**4.4.** The area is rented for a period of 20 calendar days prior to the opening, during the event and 10 days after the closing of the EXHIBITION. The rent price does not cover the building of stands and bungalows, graphic design, staff, materials and other services. Upon EXHIBITOR's written request, they may be provided with corner (two-sides open) or central (three- or four-sides open) net indoor exhibition area against a surcharge of 15% of the area rent price.

**4.5.** All EXHIBITORS who rent indoor exhibition area are required to have a stand built.

**4.6.** Outdoor exhibition structures must be built with a depth of at least 3 m and high wind resistance.

**4.7.** The removal of exhibits and stand materials from the rented exhibition area may start after 16:00 on the closing day of the EXHIBITION.

#### **5. CONSTRUCTION.**

**5.1.** Construction of stands and bungalows by the ORGANIZER

By order of the EXHIBITOR, the ORGANIZER provides the service of building stands and bungalows with modular aluminum and non-standard construction, as well as unique stands and bungalows. Requests are specified using Form 4. Furnishings, support staff, and other services of the requested stands/bungalows may be requested through Furnishing Order - form 5, which is sent simultaneously with Form 4

**5.2.** Construction of exhibition stands and bungalows by an EXHIBITOR or contractor.

**5.2.1.** Construction fee.

THE EXHIBITOR builds stands and bungalows, either individually or through assignment to another contractor and the relations with INTERNATIONAL FAIR PLOVDIV AD are regulated by a construction contract. In order to cover the total cost of electricity and water, for cleaning the common parts and waste disposal, for using the infrastructure, for overall security and surveillance by the authorized services during the period of assembly and disassembly, the person who builds the stand or the bungalow shall pay a Construction Fee according to Form 4 of the International Fair Plovdiv AD.

**5.2.2.** Project approval.

All projects for construction and graphic design of the stands/bungalows shall be submitted for approval to International Fair Plovdiv AD, subject to a Project Approval Fee as per Form 4. The technical and financial requirements for them shall be specified in the contract on construction of exhibition structures.

**5.2.3.** THE ORGANIZER is entitled to refuse to sign a Construction Contract with a person, who builds stands, bungalows or provides other services if THE COMPANY or THE EXHIBITOR has outstanding financial obligations to THE ORGANIZER and/or to the International Fair Plovdiv AD or if the projects do not meet the technical requirements and safety conditions.

**5.2.4.** The construction, the artistic layout and the arrangement of the exhibition and advertising areas must be completed within the stipulated workhours the day prior to the opening of event.

**5.2.5.** It is prohibited to make changes to the walls, the floors, the ceilings and other structural elements of the pavilions and the pavement of the open areas except with the written consent of International Fair Plovdiv AD. All damages resulting from the guilty behavior of THE EXHIBITOR/THE CONTRACTOR shall be removed by it or by International Fair Plovdiv AD at the expense of THE EXHIBITOR/THE CONTRACTOR.

**5.2.6.** All power supply from the main switchboards and water supply systems shall be carried out by specialists of International Fair Plovdiv AD and shall be paid for according to Order Form for Electric and Water Connection – Form 10.

**5.2.7.** The Organizer together with the International Fair Plovdiv AD has the exclusive right to grant permission for any kind of lawful activity on the territory of the exhibition area after the conclusion of a contract.

#### **6. SECURITY.**

**6.1.** THE ORGANIZER shall provide the general security of the EXHIBITION. To ensure access to the territory of International Fair Plovdiv AD and of the EXHIBITION, the EXHIBITOR shall send to THE ORGANIZER a list of the names of its representatives / stand staff through the Application for Badges for Exhibitors (Form 8). The EXHIBITORS and their staff will not be admitted to the exhibition area after the visiting hours as set out in Section V, Item 2. If the exhibits require special security measures, THE EXHIBITOR may hire security staff only through the ORGANIZER.

**6.2.** Moving exhibits during the opening hours of the EXHIBITION is prohibited. In case exhibited small arms need to be taken out and back into the pavilion, they must be checked by the Military Police Service Mod. Making films and taking photographs of exhibits and stands without the written consent of the ORGANIZER is prohibited.

**6.3.** Vehicles are not allowed to move freely around the ground of International Fair Plovdiv. Parking is allowed only at the designated parking lots with parking passes.

#### **7. NON-DISTURBING USE**

**7.1.** The use of rented area should not disturb and interfere with the use of the surrounding stands. When using audio media, the volume must match the overall surrounding sound level and not cause problems to other EXHIBITORS. At any time during the exhibition, THE ORGANIZER may give mandatory instructions to immediately stop using audio without giving reasons and without having to take into consideration the arguments presented by the EXHIBITOR.

**7.2.** EXHIBITORS declare that they will not undertake actions that violate decency, constitute unfair competition or violate copyright and related rights.

## 8. ПРОТИВОПОЖАРНИ ИЗИСКВАНИЯ И ОХРАНА НА ТРУДА.

**8.1.** ИЗЛОЖИТЕЛЯТ е длъжен да осигури спазването на правилата за безопасност, охрана на труда и противопожарните правила лично и от страна на своите работници и/или тези на наети фирми, като всички неблагоприятни последици от неспазването им са за негова сметка. Загълъжението да застрахова персонала и техниката е в неговите отговорности.

**8.2.** Забранено е движение на експонати на собствен ход на територията на панаира извън изложбената площ на ИЗЛОЖИТЕЛЯ през времетраенето на проявата, освен с писмено разрешение от ОРГАНИЗАТОРА.

**8.3.** От съображения за противопожарна безопасност всеки ИЗЛОЖИТЕЛ трябва да импрегнира щандовия материал с противопожарно покритие и да представи сертификат, доказващ че материалите са импрегнирани. В противен случай ОРГАНИЗАТОРЪТ извършва импрегнирането за сметка на ИЗЛОЖИТЕЛЯ. ИЗЛОЖИТЕЛЯТ трябва да осигури свободен достъп до пожарните кранове и хидрантите. ## 8. FIRE SAFETY AND OCCUPATIONAL HEALTH AND SAFETY REQUIREMENTS.

**8.1.** The EXHIBITOR must comply and make sure their staff and/or the staff of third-party service providers comply with the occupational health and safety requirements and fire safety requirements; any negative consequences from failure to comply shall be at their expense. It is exhibitor's responsibility to have their staff and equipment insured.

**8.2.** Exhibits are not allowed to drive around the fair ground outside the limits of EXHIBITOR's allocated exhibition area for the duration of the event without ORGANISER's written consent.

**8.3.** For fire safety reasons, each EXHIBITOR must impregnate the stand material with flame retardant coating and produce a certificate proving that the materials are impregnated. Otherwise, the ORGANIZER shall perform the impregnation at the expense of the EXHIBITOR. The EXHIBITOR must provide free access to fire taps and hydrants. The electrical wiring of the stand must comply with the fire applicable safety requirements in the Republic of Bulgaria. It is forbidden to store empty packages and flammable materials at / behind the stand.

## 9. PERSONAL DATA PROTECTION.

**9.1.** As data controller, INTERNATIONAL FAIR PLOVDIV AD shall process and store personal data of EXHIBITORS insofar such data is provided by the exhibitors at the time of submission of their application for participation. Individuals' data that are publicly available as part of a company file, which the exhibitor has made publicly available through the Trade Register kept by the Registry Agency shall be processed by International Fair Plovdiv AD in full compliance with the General Data Protection Regulation and the Privacy and Data Protection Policy of International Fair Plovdiv AD.

**9.2.** Applications for participation in the EXHIBITION only require personal data from EXHIBITORS who are individuals; where the EXHIBITOR is a company, only company data that is publicly available from the REGISTER OF COMPANIES is required.

**9.3.** INTERNATIONAL FAIR PLOVDIV AD does not require or collect information containing personal data of individuals employed by the EXHIBITOR or of their clients, suppliers or individuals related in any way to the EXHIBITOR.

**9.4.** Information that any EXHIBITOR or VISITOR has in any way provided to the International Fair Plovdiv and which is not required and is not subject to storage and processing shall be destroyed in accordance with the applicable rules for the destruction and deletion of personal data.

**9.5.** When conducting marketing research, PLOVDIV INTERNATIONAL FAIR only processes personal data for the purposes of the respective research, and data are collected on the basis of explicit consent upon submission of a confidentiality notice.

**9.6.** Respondents are asked to fill in a questionnaire after they give their informed consent for participation and data processing.

**9.7.** All personal data that INTERNATIONAL FAIR PLOVDIV may obtain in connection with exhibitor's participation to fair event(s) shall be processed in compliance with the applicable legislation only for the specific purposes and on the specified grounds, and they will be transmitted to third parties for processing in order to meet contractual or regulatory obligations, and where the purpose of data collection is direct marketing this shall be done with EXHIBITOR's explicit consent.

## 10. MISCELLANEOUS

**10.1.** Each exhibitor acknowledges and accepts that the exhibits and products that they exhibit may be photographed and filmed before and during the EXHIBITION. Photographs and film material may be used to promote the EXHIBITION. In the event that an EXHIBITOR does not want their trademark, logo, sign, etc. to be used by the ORGANIZER in the materials and events announcing and presenting the EXHIBITION, they must state this in writing until the beginning of the day preceding the opening day of the exhibition.

**10.2.** Each EXHIBITOR agrees for the data submitted by it, such as name, address and registered office, scope of activity, etc. to be published in the printed and online catalogue of THE EXHIBITION.

## VI. ADDITIONAL SERVICES.

### 1. PRESS CENTRE.

The Press Centre of International Fair Plovdiv serves accredited journalists by offering telephone, fax and all that is needed for press conferences, meetings and discussions between journalists and EXHIBITORS.

### 2. DEMONSTRATIONS.

**2.1.** The ORGANIZER provides opportunities for demonstrations of the exhibits in places designated for that purpose. The exhibitor declares their wish to demonstrate in Form 2.

**2.2.** Participation of an EXHIBITOR in demonstration shootings organized outside the territory of the INTERNATIONAL FAIR PLOVDIV may be organized by sending the Application for participation in demonstration shootings - Form 2A and the Annex thereto.

### 3. EXHIBITION CATALOGUE AND INFORMATION SYSTEM (IS).

The organizer and International Fair Plovdiv AD jointly publish a printed and online catalogue of the exhibitors, publish a list of all participants on their websites and maintain an information system for them. The organizer and International Fair Plovdiv AD are not responsible for the accuracy of the data provided by THE EXHIBITOR. The inclusion in the catalogue and in the IS of the address of the company, phone number, fax number, e-mail, website, up to two branches and text information up to 50 characters is obligatory and free of charge for all EXHIBITORS and SUB-EXHIBITORS, the data being taken from the Application for Participation Form (Form 1 or 1B). In case of necessity for change and/or complementing this data, Form 3 – Catalogue and Information System shall be filled in and sent within the specified term. #### 4. PRESENTATIONS, SEMINARS, SYMPOSIUMS.

The ORGANIZER jointly with International Fair Plovdiv AD provide the EXHIBITORS/the VISITORS with halls and technical equipment for rent for holding presentations, seminars, symposiums, business meetings and other accompanying events. For the purpose, the EXHIBITORS/ the VISITORS conclude a contract with the ORGANIZER by filling in an Application Rental Request Form for Halls and Technical Equipment – Form 7 in writing. The requested events are announced on the websites of the ORGANIZER and INTERNATIONAL FAIR PLOVDIV AD.

#### 5. FORWARDING SERVICES.

5.1. The ORGANIZER jointly with International Fair Plovdiv AD perform the following:  
- loading and unloading operations (Form 15);  
- settlement of customs formalities;  
- transport and storage of wrapping and containers;  
- transport and storage of exhibits in a warehouse under customs control.  
To request transport services, The Transport Services Order – Form 15 may be used.

5.2. The EXHIBITOR is not allowed to perform separate loading and unloading of exhibits, as well as access, respectively use of own or rented mechanical means (cranes, forklifts, etc.). The costs for these services are calculated and paid at a special tariff, valid for all international events held on the territory of International Fair Plovdiv AD, which is provided (sent) to the EXHIBITOR upon request.

#### 6. INSURANCE.

The EXHIBITOR bears the risk and responsibility for transport, storage and display of the exhibits and stand material. To guarantee its interests, it must insure its property against any risks during the stay of its property at the EXHIBITION.

#### 7. CUSTOMS FORMALITIES.

Customs clearance of temporary import and export can be done by the specialized service at International Fair Plovdiv AD and/or a forwarding company, authorized by INTERNATIONAL FAIR PLOVDIV AD that are guarantors to the Customs. Foreign exhibitors must have a Confirmation of their Application for Participation by the ORGANIZER of the EXHIBITION and a Permit for Temporary Export and Re-import or Temporary Admission and Re-export for participation in trade exhibitions, issued by the Interdepartmental Commission for Export Control and Nonproliferation of Weapons of Mass Destruction. The exportation of exhibits under customs control from the exhibition area is only possible with the permission of the customs authorities. In case of nonobservance of this condition, the EXHIBITORS shall be sanctioned by the Customs with the fines, fees and duties envisaged.

#### VII. FINAL PROVISIONS

The Bulgarian Substantive Law shall govern the relations between the parties upon the signing of a Contract under these General Terms and Conditions.

All disputes arising between the ORGANIZER and the EXHIBITOR, on the other hand, shall be resolved by negotiation, if necessary, and with the assistance of the FAIR as the MAIN PARTNER.

If no agreement is reached, the dispute shall be referred to the competent Bulgarian court. When distraint of exhibits is necessary, the Bulgarian Civil Procedure Code shall apply.

The ORGANIZER of the exhibition reserves the right to amend or update these General Participation Terms, the forms and rate for which he should publish notification to the exhibitors on the website of the exhibition <http://www.hemusbg.org>, reading the amended general participation terms, forms and rates. In case of amendments / updates, they shall remain effective in their latest version. Amendments or updates may not be made later than 20 calendar days prior to the start of the exhibition.

These General Terms and Conditions are printed in Bulgarian and in English language. The version in Bulgarian language shall be accepted in case of disputes.

# ‘Hemus 2022’ Post-event Overview

## INTERNATIONAL DEFENCE EQUIPMENT AND SERVICES EXHIBITION „HEMUS 2022“, THE FIFTEENTH EDITION

**01.06.2022 – 04.06.2022, PLOVDIV, BULGARIA**

*„TRADITION, outstanding PERFORMANCE, growing SUCCESS, STABILITY“*

### OVERVIEW

The Fifteenth edition of the International Defence Equipment and Services Exhibition „Hemus 2022“ took place from 1-st to 4-th June, 2022 at the Plovdiv International Fair. The Event was held in complex geopolitical and economic conditions. Significant efforts were made by the organizers to ensure not only attractive but also safe venue and conditions for exhibitors and visitors.

Despite the complex situation, “Hemus 2022” has achieved significant growth in all trade parameters compared to the previous edition in 2020. In particular, “Hemus 2022” has expanded the indoor and especially the outdoor exhibition area to accommodate the increased number of exhibitors. A significant number of new exhibitors from countries new to “Hemus” successfully participated in this edition.

On an exhibition area of a total of 4284 sq.m., of which 2039 sq.m. covered and 2245 sq.m. opened, 100 companies and organizations were presented, of which 59 Bulgarian and 41 foreign from 21 countries, namely the Republic of Austria, the Australian Union, the Kingdom of Belgium, the Republic of Bulgaria, the Federal Republic of Germany (8 companies), the Republic of Greece, the State of Israel (4 companies), Republic of India, Kingdom of Spain (2 companies), Republic of Italy, Republic of Lithuania (2 companies), Kingdom of Norway, Islamic Republic of Pakistan, Republic of Poland, Romania, USA, Republic of Serbia, Republic of Turkey, Republic of Finland (3 companies), Republic of France (3 companies) and the Czech Republic (2 companies).

Among our esteemed exhibitors, to whom we offered hosting, was once again a Contingent from the US Army, which participated in the Static Display together with Bulgarian military formations. This contingent, as well as the military personnel from the United Kingdom who visited the exhibition, were part of the NATO Multinational Battalion Battlegroup formed on the territory of the Republic of Bulgaria.





The Bulgarian Academia continued to show significant interest, as a total of 11 Scientific bodies and Universities, of which 5 military and 6 civilian, took part as exhibitors in „Hemus 2022“.

In general, regardless of the complex economic and geopolitical situation in the world, the achieved commercial parameters of „Hemus 2022“ exceeded by 10% to 50% what was achieved in the previous edition.

This edition of the exhibition caused widespread interest and visits from a number of representatives of the Bulgarian state institutions, from official delegations and guests of the Minister of Defense, from the diplomatic corps, from representatives of Bulgarian and foreign business and last but not least, from numerous Bulgarian and foreign citizens. A positive trend is the attraction of new visitors from all categories, as well as high-ranking delegations from new countries while maintaining the interest of traditional visitors. For example, on the Bulgarian side, the exhibition was viewed by the President of the Republic of Bulgaria, by representatives of the Parliament, by the Minister of Defense, by Deputy Ministers of Defense, of Economy and Industry and of Innovation and Growth, by the Chief of Defense, by the Commanders of Services, Generals and Admirals.

The exhibition was also visited by 18 foreign delegations, guests of the Minister of Defense from Bosnia and Herzegovina (Minister of Defense), Republic of Iraq (Minister of Defense and Accredited Ambassador), Republic of Iraq (Iraqi Defense Industry Commission), Republic of Rwanda (Minister of Defense), Republic of North Macedonia (Deputy Minister of Defense), Arab Republic of Egypt (Accredited Ambassador and Defense Attaché), Republic of Croatia (National Armaments Director), Kingdom of Spain (National Armaments Director and Defense Attaché), Islamic Republic Pakistan (Military Delegation), Republic of Poland (Chief of the Office of the National Director of Armaments and Defense Attaché), Republic of Romania (Delegation from the Ministry of Defense), Kingdom of Saudi Arabia (Deputy Minister of Defense and Military Delegation, Defense Attaché), Republic of Greece (military delegation from the Ministry of Defense), French Republic (military delegation from the Ministry of Defense and Defense Attaché), Federal Republic of Germany (Defense Attaché), the Republic of Kosovo (Temporary Head of the Diplomatic Mission in Sofia), the European Defense Agency (Deputy Director of the Directorate for Scientific Research Activities, Technologies and Innovations), the United States (Senior Representative from the Ministry of Defense, Assistant to the Chief of Staff of the Defense Ministry of USA in Europe and Africa), NATO Agency NSPA .





Along with the official delegations, "Hemus 2022" had visitors from 50 countries from Europe, North and South America, Australia, Africa and Asia. A number of countries were represented by their Defense Attachés in Sofia and other visitors.

The total number of visitors to the exhibition and its accompanying events exceeded 3,000 people, which means that the positive trend of increasing attendance is maintained. This increase is mainly due to the growth in the interest shown by the representatives of the Bulgarian state institutions, the private business, the Bulgarian academic environment and the visitors at the invitation of the foreign and our exhibitors.

The conducted independent sociological survey takes into account the complicated geopolitical and economic situation in which „Hemus 2022“ was held. In this conditions, the edition managed to attract a significant number of new exhibitors and visitors, and was marked by an overall good realization of the previously set goals. The results of the survey show that there are sufficient prerequisites for high levels of overall satisfaction and intentions to participate in "Hemus 2024". In conclusion, the survey registers a growing trust in the specialized exhibition and a high assessment of the concrete rational benefits of it.

The exhibition and accompanying events were covered by representatives of over 36 Bulgarian and foreign media.

The exposition in practice continues to cover the full cycle of the development of a defiance product or service – education and training, innovation, R&D, production, commercialization, acquisition, lifecycle support and utilization.

The expanded international participation and the strong international, European and Euro-Atlantic interest shown in the exhibition made it a high-level international forum for the realization of interests, both in the business-to-business domain, as well as in the state-to-state and business-to-state domains.

In this way, „Hemus 2022“ has proven the trend not only to be a growing success over the years, but also established itself as one of the most reliable partners of national and international institutions, the armed forces, the defense industry and the academic community in the interest of national security and industrial development.

Therefore, we once again and proudly confirm the main essential characteristics of „Hemus“, namely:



## OPENING, ACCOMPANYING EVENTS AND CLOSING OF THE EXHIBITION

The exhibition was opened by the President of the Republic of Bulgaria and Supreme Commander in Chief of the Armed Forces, Rumen Radev. The Minister of Defense, Dragomir Zakov, addressed the exhibitors and visitors with a greeting .

Among the officials at the opening ceremony were also the Chief Secretary and Advisers to the president of the Republic of Bulgaria, representatives from the Parliament, the Deputy Ministers of Defence, Economy and Industry and Innovation and Growth, the Chief of Defense, the Commanders of the Services, Generals and Admirals, the Ministers of Defence of Bosnia and Herzegovina, Iraq and Rwanda, the Deputy Ministers of Defence of the Kingdom of Saudi Arabia and the Republic of North Macedonia, Heads of over 20 diplomatic missions in our country, over 50 accredited Defence Attachés and Trade Attachés, as well as many Bulgarian and foreign guests.

Immediately after the opening, according to established tradition, a dynamic display was held, in which a helicopter and airplanes from the Bulgarian Air Force took part.



Traditionally, before the opening, a press conference was held where the representatives of the media were informed by the Director General of the Plovdiv International Fair about the importance of the exhibition and its main parameters. The Deputy Minister of Defence, in his capacity as the Main representative of the Organizing Committee for the preparation and organization of the exhibition, emphasized the fact that the exhibition traditionally continues to mark a significant increase in participating exhibitors and visitors, as well as in the occupied exhibition areas compared to the previous edition. It was also noted that the growth of international interest in „Hemus 2022“ and the international nature of the event and its accompanying events is also significant, as the exhibition was visited by 18 foreign official delegations, three ministers of defense, two deputy ministers, a number of national directors on armaments, etc.

The Deputy Minister of Economy and Industry emphasized that with its 15th edition, the International Defence Equipment and Services Exhibition „Hemus 2022“ is once again confirmed as a significant Event in South-Eastern Europe of products and technologies for defence and security. Proof of this is the wide participation of Bulgarian and foreign companies and government representatives. Today “Hemus 2022” is an established platform for presenting international industrial cooperation in defense and security, for developing existing and creating new partnerships.



## ACCOMPANYING EVENTS

### *Business meetings*

„Hemus 2022“ has established itself as an extremely successful platform for business meetings of all kinds - g2g, g2b, b2b. Thanks to a previously reworked mechanism, more than 60 business meetings of various types were requested, organized and held, both at the request of the delegations and other visitors, and at the request of the exhibitors themselves.

Regarding the g2g format , all official delegations held business meetings with the leadership of the Bulgarian Ministry of Defense, and many of them - bilaterally.

Regarding the b2b format, more important were the presentations made by the companies „Elta Systems“, „Rafael“, „Patria“, „Elbit“, „Samel-90“, „Sage Consultancy“ and others. More than 30 exhibitors declared and held business meetings with their business partners.




### *Live Demonstrations*

Immediately after the opening and according to the tradition restored in 2020, live demonstrations were held. A Mi-17 helicopter with the Bulgarian National Flag and two MiG-29 aircraft from the Bulgarian Air Force took part in the show.



### *Static display of armament and equipment of the Armed Forces of the Republic of Bulgaria, the Ministry of Interior of the country and the European Command of the United States Armed Forces*

Exhibits were displayed in 10 centers - Armored Vehicles, Weapons, Optical Instruments and Special Equipment, Means of Personal and Ballistic Protection, Special Equipment and Laboratory Equipment, Modeling and Simulation Systems, Air Force Field Communications and Aviation Equipment, Specialized Vehicles, Center for equipment of the Ministry of the Interior and the equipment center of the European Command of the US Armed Forces, which presented three armored combat vehicles of the infantry, as well as an unmanned aerial vehicle of close action.



### *Live Firings*

Live Firings were held on 3-rd June at The Central Artillery Technical Testing Range „ Zmejovo“.

Nine (9) companies and organizations took part in the demonstration shootings. During the event 24 new defence products were demonstrated by the following Bulgarian manufacturers from the defensive industry - „VMZ“ JSC – Sopot, „ Transmobil „ EOOD, „ARCUS“ JSC - Lyaskovetz, „AHELOJ OPM“ Ltd. - Sofia, „DUNARIT“ JSC - Ruse, Optics AD – Panagyurishte, Sage Consultants AD and „METALIKA AB“ Ltd. - Sofia. The Central Artillery Technical Testing Range "Zmejovo" demonstrated ammunition tests as well.

On the Bulgarian side, the live firings were observed by the Deputy Minister of Defense, the Commander of the Navy, the Director of the Arms Policy Directorate - Ministry of Defense, as well as officers and employees from the Defense Headquarters, the Land Forces, the Navy and the National Military University „Vasil Levski“ - town of Veliko Tarnovo.

The live firings aroused wide interest among the high-ranking guests and visitors of the exhibition, as well as among exhibitors from the country and abroad. Among those present were the delegations of Rwanda (Minister of Defense) and Iraq (Defence Industry Commission), defense representatives/attaches of the Embassies of United Kingdom, Germany, Israel, Indonesia and Greece in Bulgaria, representatives of the Defense Research Institute, France, of the Police Service of Northern Ireland, United Kingdom, of VVT Technical Research Center of Finland, Finland. At the invitation of Bulgarian companies, guests from Congo, Indonesia, Ukraine and Belgium participated. The shootings were also observed by representatives of a significant number of Bulgarian and foreign companies, including Yugoimport, Serbia, LOMINI and EMKO, Bulgaria, Partia, Finland and General Dynamics Land Systems, Switzerland.

Firings were broadcasted on alive on the territory of the exhibition, on the monitors of the information stands in both halls.



## *International Scientific Conference*

The Eleventh International Scientific Conference „Scientific research, technology and innovation - a basis for building new defense capabilities“ was held on June 2 and 3, 2022.

Greetings to the participants and guests of the conference were addressed by the Deputy Minister of Defense, by the Head of the Military Academy „G. S. Rakovski“ and by the Director of the Institute of Information and Security at the University of Library Science and Information Technologies, etc.

The Deputy Minister of Defense, in his welcome to the participants of the conference, emphasized that it is essential to search for good and rational solutions for the development of defense capabilities, saying that at a meeting with representatives of the European Defense Agency, emphasis was placed on the joint development, acquisition, investment and maintenance in equipment, technologies and resources, as we jointly participate in the operations conducted.

Among the main highlights of the conference were the prospects for the development of scientific research and technology and the implementation of innovative solutions for increasing the country's defense capabilities and modernization of the Armed Forces. Discussions and sharing of different ideas and solutions took place in three scientific sessions of the conference. They were attended by the Director of the Operations Support Directorate at the NATO NSPA Agency, the Head of the Air and Land Combat Systems Program at the NATO NSPA Agency, the Director of the Defense Institute and the Deputy Director of the Institute of Information and Communication Technologies – BAS.

More than 120 delegates and guests from the country and abroad took part in the event. More than 60 scientific reports were presented.



## *International Symposium*

On 31.05.2022 as a **new** accompanying event within “Hemus 2022” the first Symposium on Research and Innovation for European Security and Defense (RISE-SD) was held.

The purpose of the Symposium was to exchange knowledge and experience, to share achieved results and to deepen cooperation in the field of security and defense to more fully use the opportunities provided by new technological trends and scientific achievements. Greetings were given by the Deputy Minister of Innovation and Growth, the Deputy Minister of Defense, a representative of the European Commission, the General Manager of AFCEA Europe, etc.

The Symposium was attended by more than 30 speakers on projects funded by the European Union, as

well as representatives of EDA, Directorate General for Defense Industry and Space (DG DEFIS), European Commission, NATO Science and Technology Organization (NATO STO) and others .

The Symposium was a tribune of more than 100 specialists from various European institutes, scientific and business organizations gathered to exchange experiences and establish lasting and useful direct connections.



### *Hackathon Competition "DefInSpace Bulgaria 2022"*

The competition was held on June 3 and 4 as a **new** accompanying event within "Hemus 2022". It was organized by the Office for Transfer of Aerospace Technologies, Bulgarian Academy of Sciences, under the patronage of the Embassy of France in Bulgaria .

DefInSpace 2022 is the first international innovation competition with a focus on the application of space technologies in the field of defense and security. Initiated by the French Space Command in France ( Commandement de l'Espace ) and organized by the French aerospace cluster „Aerospace Valley,, in 2021.

For the international opening of the hackathon online greetings were given by Major General Michel Friedling, commander of the French Space Command and Bruno Darboux , vice president of Aerospace Valley.

Eleven teams participated in the competition, solving challenges set by the French Space Command related to Space traffic management.

During the event, a number of presentations were given by representatives of science, defense and business.



## Industrial Forum

The Industrial Forum entitled „Bulgaria’s priorities for the development of defense capabilities and innovations in defense - implementation of enhanced military-technical cooperation within the EU and NATO“ was held on June 1, as part of „Hemus 2022“.

The Forum was attended by the Deputy Minister of Economy and Industry, the Deputy Minister of Innovation and Growth, representatives of the Council of Ministers, the Ministry of Economy, the Ministry of Defense, the European Defense Agency, as well as representatives of the Bulgarian and foreign defense industry, scientific institutes and organizations.



## CLOSING THE EXHIBITION

The closing ceremony was held on June 4 from 10:30 a.m. to 1:00 p.m. The Deputy Minister of Defense, Stanimir Georgiev, presented a plaque to each of the exhibitors, as well as certificates for innovative developments presented at the exhibition to six teams from Vasil Levski National University „,Artillery, Air Defense and CSI“, Shumen.

The organizers and the Plovdiv International Fair presented each exhibitor with a Certificate of Participation.
